



Dear Ms. Wright:

Thank you again for the Utah State Bar's generous donation to allow Utah Dispute Resolution to hire a consultant as we navigate our executive transition. This is an update on the state of Utah Dispute Resolution and how the consultant, Kai Wilson with Pathway Associates, has helped us.

We have weekly sessions for us to discuss issues, ask questions, learn about nonprofit best practices, assign tasks and report back to keep the process moving along. Kai has also been available for additional meetings, calls, and email advice as needed. Some key achievements from the engagement to date include:

- Providing a list of organizational documents that we should or may have. This process helped me
 learn about UDR's policies, procedures and the administrative and oversight systems with which
 I was not familiar. Kai has reviewed these documents and is working with me to discuss how
 UDR's practices comport with policies and procedures and making recommendations for
 amendments.
- Addressing immediate financial concerns:
 - o Ensured sufficient cash flow for the next several months.
 - O Verified that payroll taxes are being paid and are current.
 - o Verified that IRS Form 990s have been filed and recommended that the entire Board review UDR's Form 990 tax report with the auditor before filing.
 - We have a three-hour meeting scheduled to go through financial policies and procedures and internal controls and comparing those to our actual practice scheduled in March.
- Verified:
 - o UDR's corporate registration is active.
 - UDR's Charitable Solicitation Permit is current.
 - UDR remains listed as a 501(c)(3) eligible organization with the Internal Revenue Service.
- Ensuring we are not missing fundraising opportunities with existing funders:
 - o Finding foundation contact information to update funders on the transition.
 - o Drafting two requests for funding.
 - o Reviewing and editing two additional grants that UDR staff drafted and a foundation report that was due.
 - Developing a fundraising calendar of all existing funders with grant due dates and reporting deadlines.
- Updating language in our donor thank you letter so that it meets IRS donation substantiation requirements.
- Advising me and the Board's Transition Committee on staffing issues.
- Sharing best governance practices with me and Board members.

MEMORANDUM

RE: Credit Card Merchant Fees on Licensing Fees

DATE: March 7, 2023

Bar staff recommend no longer charging lawyers and LPPs a 2% surcharge for using a credit card to pay licensing fees because the Bar will no longer offer an option to pay license fees by check. The Bar is switching to a fully electronic check processing system and will no longer issue or receive paper checks. Beginning with the 2023-2024 licensing cycle, the Bar will also begin accepting ACH/e-check, American Express and Discover Card.

Elimination of the 2% surcharge on licensing renewals will cost the Bar an estimated \$68,000 in surcharge revenues annually.

History of and Structure of Credit Card Fees

In June 2015 the Commission voted to begin charging a 2% surcharge on licensing credit card transactions to recoup the merchant fees paid by the Bar each year. Members who did not want to pay the fee had the option of paying by check. The 2% surcharge covers approximately 50% of the Bar's licensing merchant fees.

Over the past five years, we have PAID OUT to our credit card processors the following credit card fees:

¹ The Commission also voted to charge a credit fee on convention registration but not other CLE registrations. However, the Bar's database cannot be programmed to charge a surcharge on some CLE registrations and not others, so the Bar has never charged credit card fees on convention registrations. In 2015, the Commission decided not to charge credit card fees on Bar application fees, CLE registration fees, or NLTP fees.

Elimination of Checks

In keeping with modern financial practices, the Bar has decided to phase out the acceptance and issuance of paper checks. All payments to and from the Bar will be by credit card or electronic payment (ACH). This will streamline accounts receivable and payable processes at the Bar because employees will no longer have to manage the receipt of checks, manually record in the database receipt of checks, make deposit runs to the bank or issue suspension notices for forgotten or lost payments.

During licensing, Bar staff process approximately 2500 checks by hand during licensing and throughout the year, Bar staff and Executive Committee members handle more than 700 accounts payable checks to vendors. The switch will save hours of staff time and improve departmental efficiency. It will cut down on the risk of check fraud and enable Bar leadership to approve payments electronically instead of having to travel to the Bar offices to approve payments.

What we are Hearing from Lawyers and Large Legal Organizations

In anticipation of eliminating checks, Bar staff have reached out to law firms and governmental legal organizations who pay license fees for large numbers of lawyers by one check. The law firms are pleased with the changes, especially the acceptance of American Express. During licensing many lawyers complain to the Bar about the surcharge on credit card payments and those individuals will be pleased if we eliminate the charge.

Surcharge fees on credit card payments are difficult or prohibited for large governmental organizations. Large governmental organizations are more concerned about the time administrative staff will incur because of the change. Governmental entities with large groups of lawyers (some as large as 200-350 attorneys) who traditionally pay with one check for multiple lawyers will no longer be able to pay for multiple license renewals in a single transaction. Instead, all attorneys will be required to pay their renewal invoice before exiting the licensing screen/portal. Under the current structure, if governmental entities want to use an entity credit card or purchasing card, they will be required to pay the 2% surcharge and would incur more than a \$1,000 in surcharge fees. Additionally, if governmental entities plan to reimburse attorneys for their license renewal, many agencies will not reimburse the credit card surcharge fee. Two governmental organizations have asked if there is anyway for them to continue to pay by check. However, we cannot program our database to accept checks for some and not others. The solution for large governmental organizations is the elimination of the 2% fee.

In order to accommodate employers who will be negatively impacted by the elimination of checks and still reap the multiple administrative and safety benefits of checkless payments for the Bar, it will be worth the elimination of the credit card surcharge fees.

Rule 14-904. Funding.

Effective: 12/15/2020

- (a) The Supreme Court will provide for funding by the lawyers licensed in this state in amounts adequate for the proper payment of claims and costs of administering the Fund subject to paragraph (c).
- (b) All determinations regarding funding will be within the discretion of the Board, subject to the Supreme Court's approval.
- (c) The Bar has authority to assess its members for purposes of maintaining the Fund at sufficient levels to pay eligible claims in accordance with these rules. The Committee must report annually to the Commission on a timely basis as to known prospective claims as well as total claims paid to date so that an appropriate assessment can be made for the upcoming fiscal year. After the assessment at the beginning of the fiscal year is determined, the Fund balance must be set in an amount of at least \$200,000. The Bar will then report to the Supreme Court as to known prospective claims as well as total claims paid to date after which the final assessment and fund balance will be set with the Court's approval.
- (d) A lawyer's failure to pay any fee assessed under paragraph (c) is cause for administrative suspension from practice until payment is received.
- (e) Any lawyer whose actions have caused payment of funds to a claimant from the Fund must reimburse the Fund for all monies paid out as a result of the lawyer's conduct with interest at legal rate, in addition to payment of the assessment for the procedural costs of processing the claim and reasonable attorney fees incurred by the Office of Professional Conduct or any other attorney or investigator engaged by the Committee to investigate and process the claim as a condition of continued practice.
- (1) In lawyer discipline cases for which the Fund pays an eligible claim, the lawyer's license to practice will be administratively suspended for non-payment until the lawyer has reimbursed the Fund.



MINUTES

Friday, January 27, 2023

Utah Law and Justice Center

In Attendance: President Kristin "Katie" Woods, President-Elect Erik Christiansen, and Commissioners Tom Bayles, J. Brett Chambers, Traci Gunderson, Rick Hoffman, Beth Kennedy, Chrystal Mancuso-Smith, Mark Morris, Shawn Newell, Cara Tangaro, and Tyler Young.

1. President's Report: Katie Woods.

1.1 Present Jennifer Huntsman the 2022 Paul Moxley Mentoring Award.

The Commission presented Ms. Huntsman with the 2022 Paul Moxley Mentoring Award. She expressed her appreciation and offered comments on the importance of mentoring and the Bar's role in ensuring that new attorneys are trained.

1.2 Review Legislative Phone Conference Calendar

Ms. Wright covered the legislative phone conference calendar and also discussed several bills of interest to Bar members, including HJR2 (1st Sub), which the Bar is opposing, and SB129 (judiciary amendments), and HB 216 (business and chancery court amendments).

1.3 Spring Convention Report: Erik Christiansen

Mr. Christiansen reported that the opening speaker at the Spring Convention will be a musician who was once an addict but has now created a comprehensive well-being program in the music community.

1.4 St. George Room Reservations Reminder

Ms. Woods and Ms. Wright reminded commissioners to book their rooms in St. George.

1.5 1st and 3rd Division Bar Elections Reminder

Ms. Wright noted that February 1st is the deadline for notices of election.

1.6 TAVA and Unmind Roll Out Update

Ms. Wright reported that the Bar's new well-being initiatives are rolling out on February 1, 2023, with a kickoff CLE event that day. She noted that Martha Knudson has been kicking off efforts throughout Utah and has been pleasantly surprised to find many well-being efforts already in play.

1.7 Judicial Council Report: Margaret Plane

Ms. Plane reported that the governor recommended funding all of the judiciary's budget items. She also reported that there will be a legislative task force on justice court reform, and she mentioned a justice court bill, which will change geographic restrictions to match district courts. The bill will require that all new justice court judges have a juris doctor and salaries for justice court judges will be increased to 90% of the district court salaries. Ms. Plane reported that retired Judge Kate Appleby is working on water law curriculum. Judge Appleby is considered a national expert in this area. Ms. Plane said JPEC reported that Utah's judicial performance evaluation system is considered to be very good statistically and by and large judges think it is fair, though some have expressed concerns about low response rates and potential bias in the process.

1.8 Diversity Outreach: Beth Kennedy

Ms. Kennedy reported that 500 lawyers signed up to do early diversity outreach. The idea behind this program is to get lawyers into high schools and middle schools in underserved communities so that youth can see positive role models of lawyers and view the legal profession as a possible career choice. Ms. Kennedy reported that Bar employee Christy Abad has been an incredible resource in helping coordinate this. Dean Kronk-Warner said she would connect Ms. Kennedy with the University of Utah's DEI coordinator. Mr. Alder observed it would be important to promote these efforts by video. Ms. McKinley noted that paralegals should also be included in these presentations and said next time there is a call for volunteers, the paralegal division would put a notice in its newsletter.

2. Action Items

2.1 Nominate Bar President-elect Candidate

Ms. Kennedy moved to nominate Cara Tangaro as the President-elect. Ms. Mancuso-Smith seconded. The Commission discussed Ms. Tangaro's interest in the leadership position and her experience in the community. The motion passed unanimously.

2.2 Select Dorathy Merrill Brothers Award Recipient

Ms. Woods noted that the Dorathy Merrill Brothers Award recognizes those who help advance women in the profession. After discussion, Ms. Tangaro moved to give the award to Ashley Peck. Mr. Christiansen seconded. The motion carried unanimously.

2.3 Select Raymond Uno Award Recipient

Ms. Woods noted that the Raymond S. Uno Award is given to those who help advance

minorities in the legal profession. After discussion, Mr. Christiansen moved to award Sade Turner. Ms. Gunderson and Mr. Newell seconded. The motion carried unanimously.

2.4 Creation of the Utah State Bar Well-Being Award

The Commission discussed the creation of a well-being award, which would recognize and honor outstanding contributions to the mental, physical, and emotional health and well-being of members of Utah's legal community, and may be awarded to individuals, sections, committees, or organizations. Following discussion, the Commission decided to make the first award at the Spring Convention. Ms. Tangaro moved to create the award and to give the first award to Martha Knudsen. Mr. Christiansen seconded. The motion carried unanimously.

3. Information Items.

3.1 Bar Member Survey Report: James Roberts and Emily Young

The surveyors covered the topics outlined in the Bar's recent member survey. The survey covered collaboration and the virtual workplace, how often lawyers are working in the office versus remotely, which hearings are best done remotely versus in-person, member feelings on the Sandbox, whether the member works with a Sandbox entity, paying for the Sandbox, feelings on the new Bar's website, how often they visited the Bar's website, how well the Bar communicates on certain topics, satisfaction with Bar services, and what kind of services the Bar should provide. The surveyors offered to put together statistical reports on several topics of interest to the Commission.

4. Adjournment.

The Commission adjourned at 11:40 a.m.

5. Consent Agenda.

The Commission approved by consent the minutes of the December 16, 2022 Commission meeting.

YTD net income is \$1,477,835 and is \$7,233 less than budgeted.

<u>YTD Net Profit –Cash Basis</u>: Adding back year-to-date depreciation expense of \$105,196 and deducting capital expenditures of \$113,623, the cash basis year-to-date net profit is approximately \$8,427 lower.

Explanations for Departments with Net Profit Variances more than \$10k and 5% Over/Under Budget:

Admissions: For the first eight months of fiscal year 22/23, Admissions revenue is reporting very close to budget. However, Admissions expenses are running \$13,384 higher than budgeted. The higher than expected expenses are due to the venue rentals for the Bar exam that were more expensive than budgeted. It appears that rental prices, similar to hotel and catering costs, have increased in recent months and therefore were not accurately budgeted.

NLTP: The NLTP program is currently reporting net spending of \$3,120, compared to a budgeted \$11,595 net profit, resulting in an unfavorable variance of \$14,715. The reason for the unfavorable variance is due to NLTP fees underreporting compared to the budget. However we anticipate this variance is a timing issue related to the collection NLTP dues and will even out in the coming month.

<u>CLE</u>: The CLE department is currently reporting \$46,562 net profit compared to the budgeted net spending of \$67,776, which is a \$114,338 favorable variance, and is due to all CLE revenues exceeding budgeted estimates. The reason for the favorable revenues is to do high demand for CLE, which was unknown during budgeting due to the lingering effects of the coronavirus pandemic.

<u>Summer Convention</u>: The Summer Convention held in July 2022 in San Diego, California was projected to break-even, thereby having attendance revenues and sponsorships revenues cover all expenses. The current financials for the first eight months of fiscal year 22/23 show that the Summer Convention is reporting a \$109,000 loss due mostly to the fact that registration revenue underreported by \$86,000 and expenses for the venue including food and rental accommodations overreported by more than \$49,000.

Fall Forum: The Fall Forum was hosted in-person in November 2022 and was budgeted to break-even. However, the event is reporting a \$25,000 loss due to registrations underreporting compared to the budget.

UTAH STATE BAR

Budget and Finance Committee Financial Results as of February 28, 2023 and for the eight months then ended

Spring Convention: The 2023 Spring Convention will be held mid-March in St. George and will be the first live Spring Convention in three years due to the pandemic. The convention was budgeted to break-even and is currently reporting a \$55,602 net profit due to early registrations and little expenses paid out. We anticipate this variance will even out in March and April as expenses are paid related to the event.

<u>Bar Operations:</u> Bar Operations net spending for the first eight months of the year is more than \$108,000 less than budgeted, which is due to the investment income reporting significantly more than budgeted, as investments performed better than the prior year.

<u>Facilities:</u> Bar meeting room facilities for the first eight months of the fiscal year are reporting less net spending than budgeted. After three years of slow rental income due to the pandemic, the Bar is starting to see more demand for rental meeting space, thus the improved actual net spending compared to the budget.

Lawyers and LPPs may receive a rebate of the proportion of their annual Bar license fee expended for such activities

during April 1, 2022, through March 31, 2023, by notifying Financial Director Lauren Stout at lauren.stout@utahbar.org.

The proportional amount of fees provided in the rebate include funds spent for lobbyists, staff time spent on legislative matters, and expenses for Bar delegates to travel to the American Bar Association House of Delegates. Prior year rebates have averaged approximately \$7.38. The rebate amount will be calculated April 1, 2023, and we expect the amount to be consistent with prior years.
