The following nomination is submitted by Nick Stiles, Utah Appellate Court Administrator, on behalf of the following: Jennifer Gadbois, Utah Court of Appeals' Clerk of Court, and all members of the Utah Court of Appeals including, Associate Presiding Judge Ryan Harris, Judge David Mortensen, Judge Greg Orme, Judge John Luthy, Judge Amy Oliver, and Judge Ryan Tenney. (Judge Christiansen Forster is not aware of this nomination.)

Judge Christiansen Forster is the Presiding Judge of the Utah Court of Appeals. She was appointed by her fellow judges as Presiding Judge on January 1st, 2021. Judge Christiansen Forster led the Court of Appeals through the challenging years of the COVID-19 pandemic while also overseeing significant administration changes including, expanding the Appellate Mediation Office (a free mediation service to litigants) to serve more litigants, and supported the creation of a Utah Appellate Pro Bono Pilot Program to provide pro bono counsel for individuals that can't afford counsel for their appeals. Judge Christiansen Forster also collaborated with administrative leadership to oversee the development and funding of a new (and free) appellate efiling service for litigants of Utah's Appellate Courts. Utah did not have an appellate efiling system previously.

Judge Christiansen Forster has not only been an advocate for expanding access to justice through work within Utah's Appellate Courts, she serves in leadership positions on numerous volunteer committees that are working to make the Judiciary more accessible. Judge Christiansen Forster has been the Chair of the Bar's Pro Bono Commission for nearly a decade, she also serves as the Co-Chair of the Judiciary's Strategic Plan Drafting Committee, a time-intensive committee that recently approved Utah Judiciary Strategic Plan. (Here is the link to the detailed plan: https://www.utcourts.gov/content/dam/about/admin/USC-Strategic-Plan.pdf) This plan provides metrics and goals on how to ensure the Judiciary remains open, fair, and efficient for all Utahns regardless of income, race, gender, etc. Judge Christiansen Forster also serves as Co-Chair of the Board of Appellate Court Judges, and as a judge representative on the Supreme Court's Rules of Appellate Procedure Advisory Committee.

Judge Christiansen Forster is not only engaged in Utah, she also recently served as Co-Chair of the Annual Conference Planning Committee for the Council of Chief Judges of the State Courts of Appeal.

Judge Christiansen Forster is one of Utah's finest judges, both in her adjudicative work for the Utah Court of Appeals, but also in her endless volunteer work for the broader legal community.

Dear Commissioners and Members of the Nominating Committee:

It is my honor to join in the nomination of Jonathan ("Jon") Hafen for the Utah State Bar 2025 Lawyer of the Year. It would be impossible to write in a short letter all of the reasons Jon deserves to be recognized as the 2025 Lawyer of the Year. Jon is a well-respected and renowned trial attorney, who has been practicing since 1991. Jon is a master of his trade. In an age where trials and trial experience is hard to come by, Jon has been recognized as one of the top 100 trial lawyers in the Mountain West and one of the Top 10 Lawyers in Utah. He is regularly sought out for his trial skills and impressive trial record. But Jon's skills extend far beyond trial. He works hard from the outset of any case to earn the trust and respect of his clients, the judge, and opposing counsel. He has often been able to settle cases that others thought were unsettleable because of the rapport he develops with opposing counsel and the diplomatic way he handles himself in all of his interactions.

Jon is not just an amazing lawyer, he is the best human being I know. I do not say this lightly. I have spent the entirety of my career looking up to Jon. The trait I admire most about Jon is his unwavering commitment to improving the lives of everyone around him. While many lawyers have a complicated relationship with this profession and often focus on its negatives, Jon has always seen the good in this career and feels strongly that anyone can excel in it if given the right support. He has aimed to provide that support or to improve systems that provide that support through his work on committees, sections, and divisions of the Utah State Bar and of the Federal Bar Association. I have had the pleasure and opportunity to observe him in many of these roles. He is a true leader, inspiring hundreds of lawyers on a regular basis to improve the practice of law.

At an institutional level, he plays an active role in planning and presenting continuing legal education courses that are directed at the development of skills for new attorneys. He also regularly presents to new attorneys, encouraging them to participate on various boards and committees. During these presentations, he emphasizes the important role these organizations

play in developing the attorneys' skills and practice and, moreover, the personal satisfaction one gains from contributing to the community.

He just finished his term as the President of the National Federal Bar Association, the second largest legal organization in the country with chapters in nearly every state. One of his primary goals in that role was to provide support to law students by offering them great programming aimed at improving their transition from law school to practicing lawyers. Two of his children, inspired by Jon's love of the law, had gone to law school and recently made that transition. He knew from observing the difficulties they had faced that there was a way to ease that transition and was committed to doing just that for law students across the country. With his guidance and assistance, the number of student chapters across the nation increased from 18 to 50! Thousands of law students' lives are better and their transition to practice easier because of Jon.

Jon also continues to serve as a member and is a Past President of the Utah Chapter of the Federal Bar Association and the Utah State Bar Litigation Section. In those roles and in his role as the Chair of the Utah State Bar CLE Advisory Committee, he has planned and continues to plan educational and fun CLEs on timely topics. He organizes, every year for fifteen or more years, a Federal Law Symposium in St. George. He does this nearly single-handedly. This conference involves most of the federal judges in Utah and provides really informative CLE classes to attorneys in a location that does not get the same access to programming as attorneys in Salt Lake. He also plans the Utah Trial Academy every year either in a standalone conference or as part of the Utah State Bar Fall Forum. These are among the most helpful CLEs any young (or seasoned) litigator can attend.

#### **RECOMMENDATION:**

The Utah State Bar Awards Committee met on June 6, 2025 to review the nominations for the Committee of the Year Award. The Committee discussed the merits of the Committee's nomination and finally agreed upon recommending The Fund for Client Protection Committee to the Bar Commission for consideration.

The Utah Supreme Court established the Fund for Client Protection on April 9, 1977. The purpose of the Fund for Client Protection is to promote public confidence in the administration of justice and the integrity of the legal profession by reimbursing losses caused by the dishonest conduct of lawyers and LPPs admitted and licensed to practice law in this state.

The Fund for Client Protection Committee reviews claims to the Fund for Client Protection to make sure they are valid and meet the eligibility criteria stated in the rules of the program. When several valid cases are available, hearings are scheduled to determine the amount of award, if any, that will be granted to any claimant.

To receive a recovery from the Fund, and eligible claim must be submitted to the committee within one year after "the date of the final order or discipline," "the lawyer's death," or "the date of the order of disability." The claim form asks the client to outline the nature of the claim and provide documentary information needed by the committee to evaluate the claim. Once the committee receives the claim and the underlying evidence, it conducts a hearing, upon appropriate notice to both the claimant and the subject attorney. The committee usually schedules several claims for consideration on the same day. Hearings are conducted both in-person and virtually, with very relaxed rules of evidence. At the conclusion of each hearing, the committee deliberates, makes written findings, and sends a recommendation to the Board of the Utah State Bar about the claim.

The number of claims filed with the Fund for Client Protection Committee is everincreasing and the time spent by our volunteer committee members has increased correspondingly.

Further, the Fund for Client Protection Committee is tasked with reviewing claims that are varied and often, quite sad. Here are some examples:

Client hires an attorney to perform legal services. In a series of payments, the client remits over \$15,000 to the attorney to pay for these expected services. For unexplained reasons the attorney does not perform any of the services and stops communicating with the client. The OPC prosecutes the attorney for various ethical violations and obtains an order of disbarment. Meanwhile, the client is forced to retain another attorney at additional expense. Fund for Client Protection (FCP) recommends an award of \$15,000 to the client for the amount the client paid to the first attorney and for which the client did not receive any meaningful services.

Client hires an attorney to defend the client in a DUI criminal case and pays the attorney a fixed fee of \$2,100 for the defense. After performing some services related to the defense, the attorney, who was a solo practitioner, unexpectedly dies. The OPC takes control of the attorney's files and trust accounts. The client is required to hire another attorney to finish the criminal defense. After evaluating the nature and amount of service provided by the deceased attorney, the FCP recommends an award of \$1,500 to the client. c. Client hires an attorney to negotiate and settle a debt collection action where the client is liable to the creditor on a \$66,000 default judgment. The client pays the attorney over \$21,000 for these services, but there is no evidence that the attorney ever conducted any meaningful services or negotiations on the client's behalf. The attorney also refuses to refund any of the retainer payments to the client. After an Order of Delicensure is entered against the attorney, the attorney resigns from the Bar. The client then retains another attorney, at additional expense, to defend the collection action. The FCP recommends the maximum award of \$20,000 to the client.

Practicing law is a privilege, not a right. As with all privileges, it comes with benefits and burdens. Licensed attorneys not only must comply with the Rules of Professional Conduct and the Standards of Professionalism and Civility in their relationships with clients and with each other, but they also must self-regulate the conduct of their fellow members. This is a shared duty. When, on occasion, the 1% among us stumble, and clients are hurt, the Fund for Client Protection steps in to help put some of the pieces back together and restore confidence in our profession.












### Overview

Beginning in 1996, the Judicial Council's Utah Task Force on Racial and Ethnic Fairness in the Legal System conducted a comprehensive review of the Utah criminal justice system to examine issues of racial and ethnic fairness. The Task Force published a final report that included suggestions to address equity issues found within the judicial branch, A quartercentury later, the Judiciary is reflecting on the progress made since those efforts and looking toward the future.

In 2021, the Judicial Council established the Office of Fairness and Accountability, charging it — through the Committee on Fairness and Accountability — with developing a strategic plan to address bias and inequity in the judicial system. Under the applicable Rules of Judicial Administration, this strategic plan must include "the Judiciary's goals and policy directives for meeting the court's mission for the open, fair, and efficient administration of justice under the law while also being responsive to the state's cultural, ethnic, socioeconomic, linguistic, physical, gender, and age diversities, Branch efforts in this regard will strive to eliminate bias and the appearance of bias, meet the needs of increasing numbers of self-represented litigants, remain receptive to the needs of all branch constituents, ensure that court procedures are fair and understandable, and provide culturally responsive programs

To develop this plan, the Committee on Fairness and Accountability convened a Strategic Plan Drafting Committee composed of employees and judges from every court level and district around the State. This committee has created the goals, strategies, and action items necessary to help the Judiciary meet its mission, By formalizing a strategic plan, the Judiciary can assess areas for improvement, set clear objectives, and advance its mission while upholding our commitment to excellence.



### Promoting Public Trust and Confidence

The Utah Judiciary is dedicated to upholding its constitutional duty to provide open courts that resolve disputes, interpret and apply the law, and safeguard the constitutional rights of all Utahns. The effectiveness of this role relies on maintaining public trust and confidence, as well as fostering strong relationships with the other branches of government. To uphold that trust, the Judiciary is committed to transparent communication, active community engagement, and exemplary service to the people of Utah.

# 1. President's Welcome and Reports

### 1.1 Election Results

Ms. Tangaro announced the results of the Commission Elections, with Tyler Young being elected as president elect. In the Third Division, Jess Couser was elected for a full term on the Commission. Mr. Bayles won his election for the Fifth Division. Ms. Tangaro congratulated Matt Hansen on his judicial nomination, which will open another spot on the Commission for the Second Division, as he was also re-elected.

### 1.2 Spring Convention Reports

Ms. Tangaro reported that the Spring Convention was a successful event and had great attendance.

### 1.3 Report on fee meeting with the Court

Ms. Tangaro, Ms. Wright, and Mr. Severin met with the Court for approval of the licensing fee for 2025-2026. They told the Court that eventually we will have to raise rates, probably in 2 years. The current fee has been \$425 since 2009. Overall, costs have gone up on everything and fees have not correspondingly increased. The Court is going to review various programs the Bar has been charged with executing in evaluating costs.

### 1.4 Admissions Ceremony

The next admissions ceremony is May  $20^{\text{th}}$  at the Capitol at noon. All Commissioners are encouraged to attend.

### 1.5 Annual Meeting

The Annual Meeting will be June 26<sup>th</sup> at 5pm at This is the Place. AG Derek Brown will give the keynote address.

### 2. Information and Discussion Items

### 2.1 2025 Legislative Session Recap

Ron Gordon and Michael Drechsel from the Administrative Office of the Court presented along with Jacey Skinner, Frank Pignanelli and Steve Styler, our government affairs teams. They reported that the Governmental Relations Committee reviewed over 200 bills during the 2025 legislative session. Many members of the bar reached out to their representatives, particularly about HB 512 which would have allowed the legislature to provide a recommendation to the public on whether a judge should be retained during a retention election. The recommendation would have appeared next to the judge's name on the ballot. The focus of the team was making sure that the citizens have access to the courts, and the protection of the process. During the interim, they are going to work to help explain the importance of system and that it's not about individual judges and individual decisions. The involvement of individual bar members led to members of the public being informed and getting involved. The group discussed potential challenges that may arise next year, and the importance of involving regional bar and bar affinity groups.

During the Interim Session, there is an item on bar licensure. Additionally, earlier discussions about court productivity will be revisited. There is also discussion of creating a new law school at UVU.

## 3. Reports

## 3.1 Western States Bar Conference

Mr. Young reported on the Western States Bar Conference, which was held in Arizona. He attended with Elizabeth, Aubrey and Olivia. Topics included access to justice, including such programs as the Sandbox, as well as the use of technology, including AI, to expand access to justice.

### 3.2 ABA Day in Washington DC

Mr. Christiansen reported on ABA Day in DC, which occurred in early April. Working with Frank Pignaneli, Mr. Christiansen was able to meet with members of the Utah delegation to discuss funding for the Legal Services Corporation which funds free legal services providers in all states including Utah. Mr. Christiansen reported that Utah's delegation indicated there would be no Legal Services funding in the proposed 2026 budget.

# 3.3 Report on Supreme Court Ad Hoc Committee on Regulatory Reform

Mr. Stiles reported on the Committee and working groups, which will be working from now until August, 2026. The Court has asked the working groups to study different regulatory reforms and to provide reports and recommendations based on info and data from the Sandbox and propose rule changes to the Court.

# 3.4 Bar 95th Anniversary

Ms. Weaver, Bar Communications Director, presented plans for the Bar's 95<sup>th</sup> anniversary in 2026. So far, a committee has been formed. The short-term goal is to increase public awareness and engagement leading up to the event.

### 4. Action Items

# 4.1 Approve 2025-2026 Budget for Submission to Court

Mr. Hoffman presented the proposed budget, which had been previously provided to the Commissioners for their review. We are budgeting to lose money; the controlled loss is timed with an increase to licensing fees in two years. The Commission discussed, and thanked Mr. Severin for this excellent work.

Ms. Tangaro made a motion to approve the budget. Mr. Young seconded, and the motion was unanimously approved.

# 4.2 Appoint 2026 Summer Convention Co-Chairs

Ms. Cordova discussed appointing chairs for the 2026 Summer Convention in Sun Valley. She recommended Cecilia Romero and Christina Jepson. She is continuing to look for a third person and welcomes recommendations of the Commission.

Ms. Tangaro made a motion to approve the Convention Co-Chairs. Mr. Young seconded, and the motion was unanimously approved.

# 4.3 Approve Creation of AI and the Law Committee

Mr. Borden presented (remotely) about creating and chairing an AI committee. The committee would have three main functions:

- 1. Educating members of the bar;
- 2. Allowing the Bar to be a stakeholder in the development of AI in the law policy; and
- 3. Providing legal scholarship, including setting up clinic at BYU

Mr. Borden offered to chair the newly formed committee. The Commission discussed how a new AI Committee would interact with the existing Innovation and the Law Committee.

Ms. Tangaro made a motion to approve the creation of the AI and the Law Committee. Mr. Newell seconded, and the motion was unanimously approved.

YTD net profit is \$720,321 and is \$(70,770) less than budgeted.

<u>YTD Net Profit –Cash Basis</u>: Adding back year-to-date depreciation expense of \$145,007 and deducting capital expenditures of \$117,902 the cash basis year-to-date net profit is \$27,095 higher.

# Explanations for Departments with Net Profit Variances more than \$10k and 5% Over/Under Budget:

<u>Admissions</u>: Admissions revenue for attorney exam fees and laptop fees has fallen short of budgeted amounts through March by (\$36,686). Laptop fees were budgeted to be increased this fiscal year; however, this adjustment did not happen, leading to a 28% budget-to-actual for that revenue category. This is being monitored, but the expectation is that this trend will continue through the end of the fiscal year. Expenses are right on track to hit the budget.

**NLTP:** The NLTP fees are (\$6,836) unfavorable YTD. Lower enrollment in the program than budgeted is what accounts for the shortfall. Combined with a (\$4,850) unfavorability among expenses, the total net loss YTD is (\$41).

<u>LPP:</u> The LPP Licensing Revenue was budgeted for 2024-25 with Licensing since that is where it had historically been coded; however, it is being separated out this year and therefore shows a favorable variance of \$23,699 YTD.

<u>CLE:</u> In-Person CLE Registrations are trending more popular than video library sales, which has been a trend since the end of COVID. Total budgeted revenue YTD has picked up and is 12% higher than budgeted. Program services expense is 32% higher than the budgeted number YTD, netting a (\$30,442) unfavorability YTD.

<u>Summer Convention:</u> The Summer Convention's revenue is (\$8,837) less than budgeted attributable to registration fees, while expenses are essentially flat at \$2,961 more than budgeted, netting a profit of \$12,227 YTD.

<u>Fall Forum:</u> The Fall Forum was a two-day event and thus incurred more costs than the prior fiscal year. The Fall Forum is not expected to close with a net loss, currently at a \$12,189 profit.
