


2025 Access to Justice Summit Speaker Bios



2025 Keynote



Amy Sorenson, partner at Snell & Wilmer, is a nationally recognized civil litigator with nearly three decades of experience in the federal and state courts of Utah, Nevada, and California. With a collaborative approach and an energizing presence, Amy has led high profile matters ranging from complex business litigation to federal Constitutional and statutory "bet-the-company" challenges and beyond. A trusted advisor to business both in and out of the courtroom, Amy also has led and resolved difficult internal investigations matters. Her industry-specific knowledge includes financial services, higher education, and sports and technology. Amy's leadership includes acting as Co-Chair of the Financial Services Litigation Practice Group, formerly serving on the firm's Expanded Executive Committee, and founding the Snell & Wilmer Women's Initiative, which aims to support the career development of Snell & Wilmer's women attorneys. For her community, Amy is proud to have served as Co-Chair of the Utah State Bar Access to Justice Commission since 2018 and to have led the most recent Magistrate Judge Merit Selection Panel for the United States District Court for the District of Utah.





Judge Richard E. Mrazik was appointed to the Third District Court in April 2018 by Governor Gary R. Herbert. He took the bench in June 2018 and serves Salt Lake, Summit, and Tooele counties. Judge Mrazik received a Bachelor's Degree in sociology and biology from Bowdoin College in 1999. After serving as an Americorps member at the Fourth Street Clinic in Salt Lake City, Utah, he received his law degree from the S.J. Quinney College of Law at the University of Utah in 2005. Prior to joining the bench, Judge Mrazik was a shareholder in the litigation department of Parsons Behle & Latimer. He served on the board of directors of the Utah Bar Foundation from 2013 to 2019. Judge Mrazik currently chairs the Utah Judicial Council's Standing Committee on Resources for Self-Represented Parties and serves on the board of directors of the Utah Avalanche Center.



Jonathan Puente, is the inaugural director of the Office of Fairness and Accountability at the AOC which is tasked with identifying and removing racism and bias from the Utah Courts. He received his JD from Loyola University Chicago School of Law and his BA from Brigham Young University. For the last eleven years Jon has been working in diversity, equity, and inclusion initiatives from policy development and implementation to strategic planning, to community outreach. His experience is diversified, including serving multiple times as a Diversity Director, chairing strategic planning committees, preparing and presenting workshops, working with organizations on all levels to make sure DEI principles are embedded throughout the organization. During the last five years, his focus has been on diversifying the legal profession, the bench, and increasing access to justice to marginalized communities.



Janine Liebert, serves as the Director of the Self-Help Center of the Utah State Courts. She formerly served as the Director of Public and Legal Education at LA Law Library in Los Angeles, California. Janine holds an undergraduate degree from Amherst College in Massachusetts, a Master of Arts in Liberal Arts degree from St. John's College in New Mexico and a Master of Library and Information Science degree from UCLA.

Maryt Fredrickson serves as the Chief of Staff to the Chief Justice of the Utah Supreme Court. She joined the Utah Judicial Branch in January 2025. Breakout 1: "AI & Tools for Expanding Access to Justice"



Breakout 2: "Exploring New Models for Legal Access"



<u>Devin Shakespear</u> serves as the Victim Services Coordinator for the Kane County Attorney's Office in Southern Utah, a role she has held for over 10 years. She earned her Bachelor's Degree in Criminal Justice from Southern Utah University and has dedicated her career to supporting victims of crime. In 2020, Devin became a Certified Advocate (now Domestic Violence Community Justice Advocate) through Timpanogos Legal Center.which has enabled her to expand the scope of services she offers. Through this certification, she is able to assist victims with legal advice related to protective orders, help draft the orders, and prepare clients for court proceedings. Devin is passionate about empowering victims and ensuring they have the resources and support needed to navigate the justice system.



<u>Cody Egan</u> is the Housing Services Specialist at Ogden-Weber Community Action Partnership, where he developed the Tenant Landlord Mediation Program and the Renter Education program. Cody is passionate about participating in innovative programs, including adopting Utah's first Ready to Rent renter education program and participating in Utah's first cohort for the Housing Stability Legal Advocate (HSLA) program.

Hayley graduated with honors from the BYU Law School, and is a member of the Utah State Bar.

Judge Samuel P. Chiara was appointed to the Eighth District Court by Governor Gary Herbert in August 2013. He serves in Daggett, Duchesne, and Uintah counties. Judge Chiara received a Bachelor of Science degree in accounting from the Marriott School of Management at Brigham Young University. He graduated magna cum laude receiving a juris doctorate degree from J. Reuben Clark Law School, BYU, in 1997. Prior to his appointment, Judge Chiara practiced at a firm in Price, Utah. 
