Introduction:

The Utah State Bar Database Review Committee was established September 1, 2013 to assist the Bar staff and Bar Commission in evaluating options for Bar management software because the current provider BarAlliance has announced that it will be ending its association management operations in May 2014.

Committee Members:

The Committee consists of:

- Committee Chair Hon. David Nuffer;
- Ron Bowmaster, CIO Utah State Courts;
- David Clark, CIO, Kirton McConkie; and
- Douglas French, CIO, Ray Quinney & Nebeker

Charge:

The Committee was charged with reviewing the alternative migration paths below and to explore other possible options.

Background:

The BarAlliance system currently manages all the Bar's programs including licensing, education, administration, admissions and discipline. It is highly customized to the Bar's needs. It originated in software run by the Bar on a mini-computer in the 1980s. Currently, three bar associations other than Utah use the BarAlliance system.

Possible Migration Paths:

There are three possible migration paths:

- 1. Purchase and migrate the BarAlliance system to an in-house system and contract with local developers to repair, maintain and extend the system.
- 2. Contract with a developer to build a new custom system from scratch.
- 3. Purchase off the shelf association management system (AMS) to run primary business functions and integrate with separate off the shelf software to manage OPC, Admissions, Accounting, and Utah State Bar web services.

Of these migration options, the committee members believe that the third is the best. The first option is estimated to have an initial implementation cost of \$312,375. This implementation estimate is based on resolution costs for current known issues in the BarAlliance software, and

the requirement to create local or in-house expertise to transition and refine the software. It also would require a commitment for some management and integration services from BarAlliance which it is unwilling to provide. The second option involves many unknowns and open ended costs which might be difficult to control, and likely requires a very long transition period. BarAlliance may not be able to cooperate in this transition. The cost for a custom, hosted solution using SalesForce.com would include initial scope and needs analysis (6 weeks at a bid of \$20,000 from SalesForce.Com development partner Kyazma.), development costs (determined by the needs analysis) and would not include ongoing annual licensing costs for staff of around \$50,000 (if all staff require full SF licenses) and, ongoing annual portal licensing fees at 2,000 log-ins per month of approximately \$12,000 per year.

The software and implementation cost of the third alternative is:

This total cost is high compared to software on the retail market. However, each of these packages is highly specialized and marketed to a small audience, resulting in the high costs which are typical in this market. Euclid has indicated some willingness to further discount that cost if some savings in migration if we are joined by other current BarAlliance users Nevada, Hawaii and Alaska.

The Bar is currently paying a little over \$100,000 per year for the BarAlliance subscription. The cost of the new systems would be about \$65,000 per year including their purchase and annual maintenance fees and hardware, if amortized over their 10 year operational life span.

BarAlliance Migration and Recommendation:

BarAlliance intends to exit the software market entirely when the current contract expires in May 2014 and has committed to some appropriate migration period following that date. BarAlliance CEO Sarah Spivey has stated that BA is committed to our smooth transition to another AMS solution and believes that migration may be reasonably accomplished in just a couple of months. Bar staff are not quite that optimistic about the commitment or the time required to complete a migration but believe that they can work together on a sufficient transition period which is acceptable to both parties. Ms. Spivey has had several conversations with the management of Euclid Technologies about taking over the association management systems for us, Alaska, Hawaii and Nevada. She has indicated on several occasions that Euclid would be an

appropriate vendor, capable of permitting a smooth a transition of the Bar's management and transaction systems.

Committee Recommendation:

The committee believes that the best investment for a longer-term data management and transaction processing solution would be to contract with (a) Euclid Technologies for the general AMS system; (b) New Dawn to provide case and document management system for OPC; and (c) Box Networks provide their Synergy application for the administration and applicant self-service software and database for Admissions. These three single point solutions would then be integrated for data exchange with each other with the current accounting system and with the new website for member transaction services.¹

Euclid Technologies is the proposed, option for AMS software for general Bar operations and transaction services. Euclid is an association management software provider located in Bethesda Maryland. Their AMS product is called ClearVantage. Euclid currently provides AMS solutions for a variety of trade associations across the country and includes a number of state and regional Bars (Colorado, Louisiana, South Carolina, Pennsylvania, Denver Bar, DC Bar, Alleghany County PA. Bar, and Orange County Bar.) As part of ongoing due diligence during this process Utah State Bar staff have stayed in contact with several of the other bar associations and they continue to find satisfaction with and recommend the Euclid solution.

New Dawn is a local development company that specializes in prosecution case management solutions. New Dawn has Bar Discipline experience in the Colorado Supreme Court Office of Attorney Regulation; the Texas State Bar; The Office of Chief Disciplinary Council, Missouri; and is currently implementing the State Bar of Arizona, the Attorney Grievance Commission of Maryland, and the Oklahoma Bar Association.

Box Networks is a network services and development company based in Kentucky. They provide an admissions process, records management and applicant self-services system named Synergy. Box has a paperless process which will provide better tools to applicants and greater staff efficiency while reducing the need for paper file storage and management. They currently provide this technology to Kentucky, Tennessee, and Nevada and have begun their implementation of Nebraska.

Each of these solutions offer strong process automation and reporting tools that will allow the Utah State Bar to continue to operate at current staffing levels and sustain the same rate of staff and membership growth and service demand. These recommendations will minimize the overall transition time, impact on staff, and reduce the amount of money expended to maintain dual systems during the transition preparation and migration.

¹ We recommend the "Synergy" Admissions product from Box Networks be purchased and implemented as an internal system rather than a hosted or cloud based service. This will reduce cost and for simplify and speed the integration and interaction of that module with the core AMS framework.

SIGNATURES

My name is Tasha Williams and I am a juvenile public defender applying for the position available on the Children's Justice Center State Advisory Board. Attached is my resume.

I currently represent indigent juveniles who appear on delinquency charges before Judge Christine Decker in the West Jordan Third District Court. For whatever reason, Judge Decker seems to receive a higher number of juveniles accused of sex offenses than most. I usually have between four and eight of these cases pending at a time. Because I have been in the same courtroom for more than two years, I have benefited from watching these kinds of cases from the time of disclosure to expungement. It is rare for juveniles to perpetrate against adults so in most of my cases both my client and the victim are usually interviewed at the CJC. It is easy to see why the work done at the CJC is an invaluable resource to me and my clients.

As a juvenile delinquency attorney, regular training on adolescent brain development and its effect on interviewing is essential to my practice. In fact, I attend yearly trainings with the National Juvenile Defender Resource Center that highlight its importance. I also strive to attend the yearly conference for NOJOS, the Utah Network of Juveniles Offending Sexually, which seeks to implement the best practice for treating juvenile sex offenders. In court proceedings I must ask both juvenile offenders and juvenile victims difficult questions about traumatic events. I am very cognizant of the distress these conversations can cause the victim and many other parties.

Minutes:

1. President's Report:

NEW: Curtis thanked Dean Rasband for his hospitality in hosting the meeting.

Dean Rasband in turn encouraged the Commissioners' attendance at the student reception after lunch. Curtis also mentioned the passing of Judge Anthony Quinn and asked John to send flowers as well as look for an opportunity to dedicate a program or event to his memory.

1.1 Leadership Conference Report (Tab 1)

Curtis asked those in attendance to review the materials behind Tab 1 in the packet. He described generally the conference. Eve Furse commented that it was a good format for productive discussion purposes and she enjoyed it. Rob Rice also commented that the format encouraged discussion which was different than in the past events. He said that those attending observed that the wide availability of online legal services is a concern because not only does it encroach on business, but it is problematic and often requires lawyers to correct those problems. Kenyon Dove interjected that we really need to focus on what is irreplaceable in a

"real" lawyer's service. He also said that members at the conference mentioned that they need a "benefit" to attend our conventions other than CLE credit. Herm Olsen then added that that the new format was superb. He heard attendees say that reducing the number of our current 3 conventions would probably increase attendance at the others. He also suggested that the Commission and law schools get together to identify areas of practice that are diminishing as a result of the internet

Jesse Nix said that the conference was fantastic and wondered if it were possible to schedule this opportunity twice a year. Jim Gilson opined that the format was a winner since it was interactive. He wants to follow up on some of the ideas that were expressed and do this type of thing at different events. What we ought to be doing as a Bar is being relevant by emphasizing the role of lawyers in giving counsel/advice and not so much dispensing legal information. John Baldwin observed that the average status of attendees at his table was 4 years out. That group typically takes changes in stride and are less "reactionary" than older lawyers. Mary Kay Griffin said that the attendees at her table were very interested in the Bar providing resources relating to how to manage a law practice.

Curtis asked Commissioners to summarize their discussions and provide that feedback to him.

1.2 Pro Bono Celebration Report

John Baldwin provided some examples of the types of events that the probono folks held for this occasion.

1.3 Fall Forum November 14-15

The Fall Forum will be held on Thursday night and the following Friday all day on November 14th-15th. It is the largest convention we do. Janise Macanas will be sworn-in as a new Commission during the event. John Lund wondered if we could do an electronic board for attendees to share rides and plan gatherings. Lori suggested that we could do a registration listsery to accomplish this. Eve asked if there could be an opportunity for some attendees to opt out for security or privacy reasons. Janise also inquired if we could do a "meet the Bar Commission" reception outside of the CLE events so that lawyers who can't afford or don't otherwise plan on attending could have a chance to interact with leadership.

1.4 Commission Priorities Review

Curtis asked Commissioners to review priorities #1-5 in the packet. We are still in the process of gathering information and want to meet with the court on the future of legal practice. John Baldwin said that in light of a

fair and impartial judiciary priority, a district court candidate was recently rejected by the Utah Senate. The court had initially asked the Bar for its involvement in this development but later withdrew that request. Discussion took place on the Utah Legislature vetting judicial candidates. Perhaps we need to better educate governmental offices and contact key individuals and offer our resources. It was also suggested that we invite the members of the Senate Judiciary Committee to the Annual Lawyer Legislative Breakfast.

1.5 Underemployed Lawyers Issues

Curtis said that he had a recent sobering experience when a new lawyer at the swearing-in ceremony reported to him that he would be returning to the farm to work since he could not find a job in the legal profession. Curtis then opined that we need to try harder to find opportunities for these new lawyers and encouraged Commissioners to do just that. Janise Macanas interjected that along those lines, some new lawyers simply can't afford to attend the Fall Forum. She asked Commissioners to think about creating an opportunity to meet and greet before the conference and without charge. Nate added that a non-profit law firm is engaging in community-based legal services. They are developing a niche for low income services and do a lot of divorces and criminal defense. John Lund observed that we have a demand problem in light of an over-supply of lawyers. Curtis closed the discussion by asking Commissioners to email him and John Baldwin as new legal opportunities arise.

1.6 Video Recording Licensure Issues

This issue came up a few years ago but has been resurrected. Tom Seiler reported that Rule 30 (b) (2) governing video recording for depositions done without a court reporter doesn't provide how you obtain a transcript. Court reporters are very concerned about this issue; they are required to be certified, undergo periodic training and education, but non-court reporters do not operate under these requirements. AV Reporters is a relatively new player in the market and are not required to adhere to these constraints. They make a video available at the end of the deposition which is nice but the downside is that there is no capability of these businesses to produce a quality transcript. The recordings are often poor quality with gaps and unintelligible comments. Witnesses cannot get a free transcripts copy to review for accuracy, either. Court reporters may approach legislators for a rule change.

Danielle Davis added that these videos are often sent out of the country for transcription at a cheaper cost but the quality is not good. Rob Rice said that the solution is to modify the rule. Eve Furse said that Jonathan Hafen is the chair of the appropriate Advisory Committee on the Rules of Civil

Procedure. Kenyon offered that it is nice to have market pressures to turn out transcripts faster from the court reporters, however. John Lund said that there is no way to obtain a transcript unless a lawyer or witness travels to AV offices in Spanish Fork and unless one pays a hefty fee in advance.

2. Action Items

2.1 Select Public Education Message: Sean Toomey

Sean Toomey, the Bar's Communications Director, distributed a handout (Media Coverage September 20 – October 21, 2013) and conducted a power-point presentation. He broke down the ensuing discussion down to several concepts: (1) Is this a good concept? and (2) the Mission Statement series. Several Commissioners asked if there was a way to track "results" of the different billboards Rob Rice suggested in the "hire a lawyer series" if we could insert a unique link to more information. The use of phrases was examined and eventually, Sean asked if he could get a budget in order to fine tune the billboard concepts. Curtis told Sean to proceed in accordance with the discussion (a \$45,000, \$55,000 and a \$65,000 budget with the inclusion of Modest Means promotion) and bring back the developments to the next Executive Committee meeting.

2.2 Select "Heart and Hands" Award Recipient (Tab 2)

Three individuals were nominated by our members for this award: Jensie L. Anderson, Sarah Spencer and Erin M. Stone. Each candidate was discussed in detail. After much discussion, Eve Furse moved to designate Erin Stone for the Heart and Hands Award. Kenyon Dove seconded the motion which passed unopposed.

2.3 Approve 2012-2013 Audit: Mary Kay Griffin (Tab 3)

Mary Kay reviewed the 2012-2013 Bar audit. We received a "clean opinion" and the audit went very well this year. Mary Kay proceeded to point out the audit's highlights and responded to questions, including information about the Lehman Brothers investment (we have received \$72,750 so far from our \$300,000 investment). After close of the discussion, John Lund made a motion to accept the audit. Herm Olsen seconded the motion which passed with none opposed.

3. Discussion Items

3.1 Pro Bono Commission Issues: Rob Rice

Rob reported that the Pro Bono Commission's goal for next year is to have "every lawyer check yes" on the annual licensing form. They are also

working on enlarging the working sphere for inactive lawyers to engage in pro bono activities.

3.2 Modest Means Program Issues: John Lund

John Lund reported that the Modest Means Program already has a dedicated Listserv in response to earlier suggestions. He observed that there has been 20,754 domestic law case filings in Utah District Courts in 2013 so far and that 20,657 of those have been resolved albeit fewer than 50% of these cases have had a lawyer involved. Modest Means is experiencing several calls a day in the last six months. They have made 264 referrals and 155 of those referrals have been in family law. John continued to report that while our program is good, and better than some bar associations have in place, it's significantly under-utilized. Of new lawyers who have just been admitted, 160 signed up in the program. We need to reach another level and need to convince potential clients that they need "real" lawyers. Further discussion endued. There has been an uptick in judges' referrals, but we continue to have low participation in the Uintah Basin and Carbon County areas.

3.3 Transition from the Practice of Law Issues

Curtis observed that there is a great need to help facilitate retiring lawyers in transitioning from full time legal practice. Lori echoed Curtis' thoughts and said that there was discussion at the break out session at the Leadership Conference on this topic.

4. Information Items

4.1 Database Review Status: John Baldwin

John Baldwin reported that Bar Alliance anticipates cutting our Bar database services off in May 2014. They still have not indicated that we have a viable option to purchase our current database. The committee reviewing this issue will have a recommendation at December's Commission meeting when Judge David Nuffer is scheduled to appear to discuss this issue.

4.2 Beneplace Group Benefits Report: John Baldwin (Tab 4)

We now have a fully executed Beneplace Group Benefits contract in place. Stay tuned for further developments but we plan on having access around the time of the Fall Forum.

4.3 Judicial Council Report: John Lund

John reported that the Judicial Council is debating whether to attend Snow Mass for their July monthly meeting. As most Commissioners already know, John Pearce was designated to the Utah Court of Appeals vacancy. There continues to be problems finding *guardian ad litems* to represent juveniles in court proceedings. We need to do more education of lawyers regarding the role of judges so that judicial surveys more accurately reflect judges' performance. E-filing in criminal matters becomes mandatory in March of 2014.

4.4 Lawyer Advertising Rule Proposal Update: Katherine Fox

Katherine Fox said that on November 18th, she and Rob Jeffs will be attending the Court's Advisory Committee meeting on the Rules of Professional Conduct. That committee will be discussing the proposed lawyer advertising rules. Sometime after, the court will expect the Bar's summary and analysis of the public comments submitted on the proposed rules, including the committee's written response. This process seems to be taking longer than usual in light of the fact that the petition was filed in February.

The following is a report of the meeting of the Fund for Client Protection a/k/a Client Security Fund which was held November 1, 2013 at the Law and Justice Center. The members of the Committee that were present are Committee Chair David Hamilton, Linda Barclay Mount, Audrey Hollar, Kathleen Jeffery, Miles Jensen, Mickell Jimenez, Pamela Urry and Brent Ward. Also present were Barbara Townsend from the Office of Professional Conduct and Staff Liaison Christine Critchley. The Committee considered various claims and makes the following factual analysis and recommendations:

A. Claimant:

Rebecca Hedden Jeremy M. Rogers

Involved Attorney: Disciplinary Status:

Disbarred

<u>FACTS:</u> Attorney was hired to represent Claimant for a personal injury claim and settled the claims (direct and UIM) without permission or advice of the Claimant. Two checks, one for \$25,000 from the tort feasor's carrier (Geico) and one for \$35,000 from Claimant's carrier (Farmers) were forged by Attorney. All proceeds, except a modest payment of less than \$200 to a medical provider, were kept by Attorney and lost by gambling according to Attorney.

Attorney confessed the acts to Claimant and began repayment which ultimately totaled \$14,230. The net loss to Claimant was \$22,438 after considering contracted attorney fees.

During the course of the partial repayment plan, Claimant had a second accident and Attorney indicated he would represent Claimant. Ultimately, Attorney allowed the statute of limitations to lapse.

RECOMMENDATION: The Committee recommends Claimant receive \$20,000.

B. Claimant:

Salah Awad

Involved Attorney:

Jeremy Rogers

Disciplinary Status:

Disbarred

FACTS: Claimant hired Attorney to represent him in a personal injury matter. The case was settled by Attorney with no notice or consent by Claimant. Attorney forged Claimant's

signature on the \$4,000 settlement check and retained all the proceeds. Claimant's net loss was \$2,666.80.

RECOMMENDATION: The Committee recommends Claimant receive \$2,666.80.

C. Claimant:

R. Roger Hillman

Involved Attorney:

Jeremy Rogers

Disciplinary Status:

Disbarred

FACTS: Claimant is a public defender in Las Vegas and hired Attorney to pursue a loan rescission/modification action. A \$6,500 retainer was paid. The promised lawsuit was never filed and virtually no work was performed. The involved property was ultimately lost.

RECOMMENDATION: The Committee recommends Claimant receive \$6,500.

D. Claimant:

Robert Pugh

Involved Attorney:

Rex Bray

Disciplinary Status:

Public Reprimand

<u>FACTS</u>: Claimant's solely held entity hired Attorney to defend against lawsuits seeking damages regarding lien claims. Attorney failed to return calls and attend hearings despite being paid \$2,000. Claimant did not pursue collection action against Attorney who remained in active practice.

RECOMMENDATION: The Committee recommends the claim be denied under Client Security Fund Rule 14-910(d)(7) for failure to exhaust recovery methods against Attorney.

E. Claimant:

Shemonika Graham

Involved Attorney:

Jerry D. Reynolds

Disciplinary Status:

Suspension

<u>FACTS:</u> Claimant paid \$1,715 for legal services involving a consumer protection matter. Attorney generated a billing statement with no detail for work done other than "preparation" No meaningful work was done on behalf of Claimant who ultimately received some benefit as a result of action by the Illinois Attorney General.

Attorney appeared by phone. He no longer practices law and lives in Pennsylvania. The Committee concludes this to be an unearned fee.

RECOMMENDATION: The Committee recommends Claimant receive \$1,715.

F. Claimant:

Lani M. Herrera

Involved Attorney:

Bruce L. Nelson

Disciplinary Status:

Suspension

<u>FACTS</u>: Attorney accepted \$1,500 to represent Claimant in a divorce action. Substantial work was performed by Attorney who generated a billing statement for work totaling \$2,487. Claimant was dissatisfied with Attorney's work and the billing. Attorney appeared and indicated his billing statement was accurate.

RECOMMENDATION: The Committee recommends the claim be denied as a fee dispute and negligence issues, not dishonest conduct.

G. Claimant: Joseph Mendillo
Involved Attorney: Bruce L. Nelson
Disciplinary Status: Suspension

FACTS: Claimant hired Attorney on several matters involving his construction business and paid Attorney \$2,250. Two cases were successfully resolved. A third matter resulted in a summary judgment against Claimant for more than \$30,000. Attorney failed to respond to the Summary Judgment Motion. Claimant found out about the judgment from DOPL and ultimately filed bankruptcy.

Attorney appeared and indicated he had failed to withdraw and acknowledged his failure to respond to the Summary Judgment Motion. He further indicated the fees paid were exhausted on the other cases prior to the case wherein the judgment was obtained.

RECOMMENDATION: The Committee recommends the claim be denied as a fee dispute and negligence issues, not dishonest conduct.

H. Claimant: Jose Russell Castillo
Involved Attorney: Disciplinary Status: Suspension

FACTS: Attorney was hired to obtain expungements to aid immigration issues. A \$4,000 retainer fee was paid to David Mendoza, Attorney's office manager. The Committee has encountered Mr. Mendoza several times in the past working for different lawyers and directly receiving fees. Attorney did not obtain any expungements and explained during his appearance that he worked on 402.b reductions, although none were obtained, and defended Claimant on a suspended license case in Murray Justice Court. The Committee concluded there was a partially earned fee.

RECOMMENDATION: The Committee recommends Claimant receive \$3,000.

I. Claimant: Lucas Visser
Involved Attorney: Disciplinary Status: Disbarred

FACTS: Claimant hired Attorney and paid \$750 for representation on a criminal case. After two court appearances and some preliminary work, Attorney failed to advise Claimant of a hearing date and a warrant was issued. A second case was brought against Claimant and

Attorney agreed to represent Claimant for free. A warrant was issued on the second case against Claimant for another failure to appear, ostensibly because Attorney failed to advise of a court date.

RECOMMENDATION: The Committee recommends Claimant receive \$500.

J. Claimants:

Scott Pedersen / Crystal Springs Clinic Inc.

Involved Attorney:

David E. Hardy

Disciplinary Status:

Disability

FACTS: This is a follow-up to a claim originally heard at the June 14, 2013 hearings. Crystal Springs Clinic Inc. paid Attorney an amount which could only be proven to be \$6,000 to pursue claims against Mountain View Hospital and related litigation. Attorney failed to pursue the suit for months. Ultimately, Claimant obtained Attorney's signature on a draft Complaint and filed it in Fourth District. No service was ever accomplished and the case was dismissed with prejudice.

Claimants were given additional time and opportunity to provide proof of the sum paid Attorney; however, only the \$6,000 could be proven. This represents an unearned fee.

RECOMMENDATION: The Committee recommends Claimants receive \$6,000, payable jointly to Scott Pedersen and Chrystal Springs Clinic, Inc.

The Committee has made recommendations that \$40,381.80 be paid out as compensation for the above-referenced claims. With these payments, the funds balance would be approximately \$\frac{254,\beta}{254,\beta}\$. Please contact me with any comments or questions.

CLE Department Co-sponsorship, Revenue Sharing Criteria and Use of E-Mail Addresses

Sections and Committees

1. The CLE Department may co-sponsor educational events with Bar Sections and Committees and share revenue on a 50/50 basis after the payment of all expenses. If a section or committe is using the event as a fund-raiser for a legally-oriented non-profit organization, the event must be approved by the CLE Department and proceeds may be split by agreement.

- 3. If the co-sponsor is a legally-oriented non-profit organization who is using the event as a fundraiser, the co-sponsor will receive 100% of the proceeds after the payment of all expenses.
 - 4. Advertising events co-sponsored with outside providers include:
 - a. Advertising in the Bar Journal on the Bar CLE calendar;
 - b. Listing the seminar on the Bar CLE online calendar;
 - c. Advertising via the Bar e-mail system;
- d. Administrative assistance in all aspects to bring the event to fruition and closing and paying expenses on the seminar.
- 5. Events not co-sponsored by the Bar may be listed on the Bar CLE on-line calendar. Outside providers who are not co-sponsoring with the Bar may otherwise purchase advertising in the Bar Journal. Events not co-sponsored by the Bar will not be advertised via the Bar e-mail system according to the Bar's policy on privacy of e-mail accounts.



Program helps new lawyers learn the ropes

ST. GEORGE (AP) - When attorneys graduate from law school and become licensed to practice in Utah, they enter an adversarial world in which people's money and personal liberties often depend on the outcome of a day's work.

The Utah Bar Association is helping new lawyers gain a foundation of skills and ethics to meet the demands of that profession by sponsoring a mentoring program during the first year of practice, and other states are now taking notice of the state's successes.

"I wish I'd had something like this when I was going through (my first year)," Utah Bar President Curtis Jensen said. "A lot of times we learn by hard knocks. ... In law school you learn cases and the theories and the academic side of it, but the practical side — going out and being a lawyer and dealing with clients and taking a case and solving issues aren't necessarily part of the curriculum. So we felt there was a need."

Jensen, a partner in St. George civil law firm Snow Jensen & Reece, said the New Lawyer Training Program was established in July 2009 as a way for Utah attorneys in their first year of practice to gain insights from seasoned professionals and benefit from their existing networks of colleagues.

The program now has 869 volunteer professionals approved by the Utah Supreme Court as mentors for the newcomers, and as of this summer 862 new attorneys had completed the mandatory

experience.

Tyson Horrocks, a former member of Jensen's practice who now works in commercial litigation and employment law in Salt Lake City, said the mentoring program helped him get a variety of real-world experiences when he was still starting his career.

"Many times, as young associates, you don't get your feet wet," Horrocks said. "I think (mentoring) helps get the ball rolling. . It's meant to kind of give you a variety of paths you can get some work in.'

Horrocks worked through a checklist of experiences he wanted to have under Jensen's tutelage, learning about corporate law that involved drafting documents and, as a litigation associate, about appearing in court on behalf of clients.

At times, Jensen directed him to other attorneys to gain experience with the business client work they were doing.

St. George attorney Trevor Terry also chose Jensen as a mentor even though he always expected to practice law with his father, criminal defense attorney Douglas Terry.

"My focus in law is criminal defense and personal injury. I don't handle much civil litigation," Trevor Terry said.
"(But) it is important that we at least have an understanding of everything. ... Obviously, I work with Doug, my dad. I could have chosen him to be a mentor, but I decided he's already mentoring me. What I wanted to get out of the mentoring program was (input from) one of the best civil attorneys."

The program was honored

by the American Bar Association with this year's Gambrell Professionalism Award in recognition of the Utah bar's innovation in creating a mentoring experience with quality controls, targeted developmental themes and continuing education credits.

An ABA news release issued earlier this year stated the program "has made a significant regional imprint, as other Western states have turned to Utah for inspiration and an effective program blueprint.'

Jensen said the mentoring program is also a key resource for ensuring attorneys learn the rules of ethics and civility they are expected to follow, whether it be in arguing a case in court or managing a client's money as they "help people through the legal entanglements of society.

"It reminds you that you are a member of a profession. A very noble profession," he said. "You need to maintain (clients') respect and honor. Your responsibility as the gatekeepers of fundamental rights. ... So many times, we're kind of the last resort."

Major motion picture to film at Reno, Lake Tahoe

RENO, Nev. — Filming for a major motion picture is scheduled to begin soon in northern Nevada, something the local producer says will become more common in the years ahead as some new tax incentives for the industry kick in.

Lake Tahoe and the Reno area will serve as the backdrop for the movie with the working title "Shark Movie." It features a carnivorous beast raising havoc in the tranquil waters of the azure alpine lake. Jeffrey Spilman, a producer

with Reno Tahoe Studio, said it's a thriller being directed by a local director, Jerry Duggan. He said he can't disclose the names of the stars yet, but they include some familiar Hollywood actors.

"Names you recognize and you see," Spilman told KOLO-

His Reno Tahoe Studios opened in August at the Reno Sparks Convention Center and expects to see a sharp rise in business thanks to a bill Gov. Brian Sandoval signed earlier this year granting a 19 percent tax break for filmmakers who shoot their movies in Nevada.

"The idea of the incentive is to hire local folks, do business with local companies and have an economic engine here that is really generated by the film industry," Spilman said. "Being a Reno resident here, I, of course, encourage it because that way I don't have to travel down to LA or the Bay to make films."

The tax break doesn't go into effect until Jan. 1.

Brian Perry, a local actor and producer, said the coming "Shark Movie" is the first step in setting up a production framework.

"The next couple months,

you're going to see a lot of people staging to get ready to shoot next year because they are going to want see how that incentive will actually play out," he said.

Actor Nicholas Cage was among those who traveled to Carson City in the spring to testify before the legislators in support of the tax break.

Spilman helped lawmakers write SB165, dubbed the "film production incentive." His Reno Tahoe Studios opened inside the convention center owned and operated by the Reno-Sparks Convention and Visitors Authority.
