### Notice of Commission Selection of President-elect Candidates

A lawyer Bar Commissioner who wishes to be considered as a candidate or a Bar Commissioner who wishes to recommend another lawyer in good standing on active status to be considered as a candidate shall notify the Board in writing. All letters of interest and notifications must be received no later than 5:00 p.m. on January 2, 2021. The Board may also consider other candidates at its discretion.

\*Candidates for the office of Bar President-elect may not list the names of any current voting or ex-officio members of the Commission as supporting their candidacy in any written or electronic campaign materials, including, but not limited to, any campaign materials inserted with the actual ballot; on the website; in any e-mail sent for the purposes of campaigning by the candidate or by the Bar; or in any mailings sent out by the candidate or by the Bar. Commissioners are otherwise not restricted in their rights to express opinions about Presidentelect candidates.



#### Rule 14-206. Officers.

(a) President. The president-elect automatically succeeds to the office of president pursuant to Article 1, Integration and Management.

(b) President-elect; qualifications; voting procedures.

(b)(1) A lawyer commissioner who wishes to be considered as a candidate or a commissioner who wishes to recommend the name of another lawyer in good standing on active status to be considered as a candidate must notify the Board in writing no later than January 2. The Board also may consider additional candidates at its discretion. Any such additional candidates must be nominated by a commissioner no later than the first regularly-scheduled commission meeting after January 2.

(b)(2) The Board must nominate at least one candidate to run for the office of president-elect from among the names submitted to<u>considered by</u> the Board as set forth above. The Board, by vote, must nominate those running for the office of president-elect at <u>a the first regularly</u>-scheduled <u>commission meeting after January 2</u>. Balloting for nomination to run for the office of president-elect will be by secret ballot except that commissioners not in attendance at the meeting may submit their vote in writing to the president or executive director.

(b)(3) A lawyer elected president-elect succeeds to the office of president and serves as president with authority to represent the Bar and preside at all meetings of the Board and the Bar even though the president-elect may not be serving a term as an elected commissioner. A president and president-elect who are not elected commissioners have the authority to vote on matters brought before the Board. In the event of a tie vote, the matter at hand shall fail to pass.

(b)(4) Ballots must be provided to all active lawyer licensees of the Bar containing the alphabetized names of the candidates. The ballots must be provided electronically via email to active lawyer licensees at their email address on record with the Bar at least 15 days prior to the date on which the election closes. If there is only one candidate for the office of president-elect, the ballot must be considered as a retention vote and a majority of those voting must be required to reject the sole candidate.

(b)(4)(A) Ballots must state the date they are due and be submitted no later than 9:59 p.m. Mountain Time on the day the election closes.

(b)(4)(B) The successful candidate must be notified by the Executive Director. The President must then call a meeting of the Board prior to the end of the annual meeting for the purpose of reorganizing the Board. Public announcement of election results will be made at the discretion of the president.

(b)(4)(C) The term of the new president-elect must begin when he or she is seated at the reorganization meeting of the Board.

(b)(4)(D) If any day or date set forth above falls on a Saturday, Sunday or holiday, the act required or time fixed must occur on or run from the next working day.

(b)(5) If there is a dispute as to the validity of the election it must be resolved by the Board at its first meeting after the election. Any Board member involved in the dispute must not be entitled to vote. The executive director must give written notice to each candidate of the hearing on the contested election and each candidate must have the right to be personally present, to be represented by counsel and to present proof at the hearing. The Board has the right to inquire into all matters germane to the election and dispute.

(b)(5)(A) The Board may designate a committee from among its members to hear disputed election matters, but decisions of the committee must not be effective until approved by the Board. In every contested election hearing, the Board will have the right to prescribe rules and regulations for the review or hearing.

(b)(5)(B) The decision of the Board is final.

(c) Seating new commissioners and officers. The reorganization meeting of the Board must be called to order by the outgoing president. He or she must first conduct any unfinished business before the existing Board. Thereafter, the newly-elected commissioners who have been found qualified and declared elected must be seated as members of the Board. The outgoing president must recognize and seat the new president and president-elect.

(d) Terms of office. The terms of office of the president and president-elect must run concurrently and must begin at the commencement of the annual convention and run until their successors have been seated. Notwithstanding the running of the president's term of office, all official functions of the annual convention must be presided over by the outgoing president.

(e) Duties and temporary absences. The president must preside at all meetings of the Bar and of the Board, and in the event of any temporary absence, the president-elect must perform the duties of the president. The president must represent the Bar at all appropriate functions and must perform such duties and represent the Bar and the Board as directed by the Board.

(f) Vacancies. A vacancy occurs in the office of president or president-elect by reason of death, resignation, incapacity, retirement, removal, change of residence from Utah, or upon the incumbent ceasing to be an active lawyer licensee in good standing. A vacancy must be filled by the Board from among its members by a majority vote by secret ballot of the remaining Board members. Commissioners not in attendance at the meeting may submit their vote in writing to the executive director. If a vacancy occurs in the office of president-elect a president-elect must be nominated and stand for election under Article 1, Integration and Management and paragraph (b) above.

(g) Removal. The president or president-elect may be removed from office by:

(g)(1) the vote of nine of the current voting commissioners at a meeting of which advance notice of the removal vote is given as provided in 14-204(a)(2), provided that commissioners not in attendance at the meeting may submit their vote in writing to the executive director; or

(g)(2) the vote of a majority of the active lawyer licensees voting in a special election held for the purpose of consideration of removal. Ballots must be emailed20 days after the filing of a petition calling for removal signed by 10% of the active lawyer licensees. Ballots are due 17 days after emailing and the results tabulated and announced not more than 45 days after the filing of the petition.

Effective November 1, 2020.

Judge Kate Appleby (formerly Toomey), retired at year's end, but she will continue to serve the court and the people of Utah as a senior judge. Before the Covid-specific award criteria were announced, it was my intention to nominate Kate for this award, as a fitting capstone to her distinguished career as a court of appeals judge, district court judge, and attorney in the Bar's Office of Professional Conduct. The Covid focus only makes Kate a more appropriate recipient of this award, as detailed in the letters submitted with this nomination.

As the last original appointee to the court, having served since 1987, I have had the honor of serving with 20 distinguished colleagues. This includes three judges who went on to serve on the Utah Supreme Court and one who went on to serve on the Tenth Circuit. But I can honestly say that I have had no better colleague than Kate.

She models the traits most sought in an appellate judge: intelligence, discipline, and collegiality. An excellent writer, her opinions are always solid, rarely drawing a dissent. She is open to suggestion in crafting her opinions and is generous in sharing her insights when reviewing and voting on the proposed decisions circulated by her colleagues. During her tenure on the district court, it was always a joy to review her work. Her decisions reflected a sensitivity to the parties, while also adhering to the requirements of the law. Her written decisions were always scholarly, thorough, and well reasoned. When she was appointed to the Court of Appeals, several friends in the Bar told me how much they would miss her steady hand at the trial level, but how lucky I would be to have her as a colleague. They were right!

While the supporting letters address Judge Appleby's extraordinary contributions to the Utah judiciary's response to the Covid pandemic, it is typical of her professionalism that the hundreds of hours that she devoted

to this work came out of her personal time. Despite these new demands, she was always prepared for oral argument, never late with a vote, and never late in circulating an opinion.

I was going to conclude with the observation that Kate truly is a judge's judge. While accurate, it is equally true that she is, and always has been, a lawyer's judge. She very much deserves to be recognized as Judge of the Year.

#### To Whom It May Concern:

I am writing to support the nomination of Utah Court of Appeals Judge Kate Appleby for Judge of the Year.

Judge Appleby is well known for her service, with distinction, first as a trial court judge and then as a judge on the Utah Court of Appeals. To her colleagues on the Utah Court of Appeals, Judge Appleby is a trusted and respected colleague. To the countless lawyers and parties who have come before Judge Appleby, she is a fair, balanced and exemplary jurist. What few know is that in addition to her work on the bench, Judge Appleby has contributed immeasurably to the administration of justice in Utah due to her service on the Utah Judicial Council.

The Judicial Council is responsible for the administration of the Utah judiciary. It oversees the many operational functions of the courts; including budget, human resources, audit, court level operations; facilities and security. In ordinary times, service on the Council requires countless hours of preparation and participation in the collaborative processes of the Council.

During the extraordinary time of COVID-19, these extra-judicial obligations became even more important because it fell to the Council to respond to the emergency and to steer the judiciary through the crisis. During this time, Judge Appleby served as both Vice-Chair of the Council and of its five-member Management Committee. She worked steadfastly, bringing her signature style - calm voice, analytic care, flawless preparation and commitment to principle - to every administrative task.

It is not possible to catalogue all of Judge Appleby's contributions, but a few bear mentioning here. In early March 2020, Chief Justice Mathew B. Durrant, acting on behalf of the Utah Judicial Council's administrative authority and the Utah Supreme Court's rulemaking authority, signed the first Administrative Order which outlined the courts' response to COVID-19. While the Order was amended several times during the year, the two principles established in the first Order never varied. The first principle is that the courts will remain open in service to the public. The second is that the health and safety of patrons who come to courthouses and the employees who work there will be protected, consistent with best practices and advice from public health professionals.

Judge Appleby was a strong proponent of both principles. Her commitment to the health and safety of the community and court employees was extraordinary. In every discussion, whether the topic was the Administrative Order or a proposed amendment, the pandemic risk response plan, a court policy, procedure or practice, she consistently asked whether the proposal was consistent with best practices articulated by the Utah Department of Health, the Centers for Disease Control and local health care professionals. During many months navigating COVID-19, in large part because of Judge Appleby, the Council did not stray from consideration of public health.

In addition to these contributions, Judge Appleby quickly developed the reputation as the Council's most prepared member. She spent hundreds of hours reading and note-taking in advance of every meeting

or conversation. Her service to the Council and the Management Committee was exemplary. She was both tough and supportive. She ensured excellence.

The Utah Judiciary's success in re-engineering its services and keeping its doors open during the pandemic is due in no small part to the work of Judge Kate Appleby, who retires on December 31, 2020. As the Utah courts and the Utah legal community turn the corner and look hopefully to a future free of COVID-19, it is important to note the contribution of leaders who worked tirelessly and against great odds to face this extraordinary challenge. Judge Kate Appleby is just such a leader. For these reasons, Judge Appleby should receive the 2020 Judge of the Year award.

#### TO WHOM IT MAY CONCERN:

This year marks the retirement of Judge Kate Appleby from the bench. Her career spans a decade and a half—eight years as a Third District Court judge, followed by six more years as a member of the Utah Court of Appeals. Her conscientious, deliberative, and well-reasoned work-product is well-known to all in Utah's legal community. And on that extensive body of work alone, she merits recognition as Utah's judge of the year.

What may be less well-known is her contribution to the administration of justice as a member of the Utah Judicial Council. The COVID-19 pandemic created unprecedented challenges for Utah's judiciary and the day-to-day operation of the courts. The ability of the courts to continue functioning was critical to social order and the rule of law. What we needed was calm and reasoned leadership and Judge Kate Appleby stepped confidently into that role.

As a member of the Council, she has worked tirelessly to ensure that the Courts could remain open and able to provide meaningful relief under the rule of law. This work required innovative thinking, flexibility, and countless hours of work. The work fell primarily to the Council's Management Committee—a small executive committee of which Judge Appleby has been a devoted member. Because of Judge Appleby's leadership during the pandemic, Utah's judicial system was able to issue rules of uniform operation, shift from a courthouse to an at-home work-force, adjust budget priorities, work with legislative and executive partners, and maintain employee morale. And she has done all of this quietly and without recognition, few Utah citizens knowing the degree to which she has helped them to weather the storm.

For these reasons, I cannot think of a more deserving candidate for Judge of the Year than Judge Appleby. It is my honor to recommend her for the award.

My incredible colleague just recently retired from the court and my hope is that she will be recognized and honored for her incredible service to the Utah judiciary and to the Utah State Bar. To Whom It May Concern,

I write this letter in support of the nomination of Judge Kate Appleby for Distinguished Judge of the Year for 2020. I served with Judge Appleby on the Third Judicial District Court prior to her appointment to the Utah Court of Appeals. And, for the last several years, I have served with Judge Appleby on the Utah Judicial Council and, together with the Chief Justice and a representative of the Juvenile and Justice Courts, we have compromised the Management Committee of the Judicial Council.

Judge Appleby has a distinguished career as a jurist, first as a trial court judge and then as a member of the Utah Court of Appeals. Her work as a judge is characterized by careful thought and thorough analysis of every case. She has mentored a generation of law clerks and contributed significantly to the effective operation of Utah's appellate courts. These are subjects, however, on which others are more competent than me to offer opinions and I will therefore confine my comments to the subject of Judge Appleby's long-standing and deep commitment to the effective administration of the judicial branch of government.

The administration of the judiciary is a subject about which little is known but on which much depends. Work done in this area is not typically newsworthy. When done well, it is hardly noticed. When done poorly, it reflects negatively on our entire branch and, often, our entire profession. Judge Appleby's work in this area is both long-standing and exemplary. As a fairly new District Court Judge, she volunteered to serve on the Board of District Court Judges where she contributed for years and, eventually, was elected its Chair. The Board performs a number of functions, principal among them are the education and training of District Court Judges and serving as their "voice" in matters before the Judicial Council. Following this, and her appointment to the Utah Court of Appeals, she was asked by

her colleagues to serve on the Judicial Council, which sets the policy of the judicial branch. She served as a Council member for many years was selected by the Chief Justice to serve on the Council's Management Committee, and ultimately was Vice Chair of the Council. She served in this capacity during some extraordinarily challenging times, including changes in our State Court Administrator, the reinvigoration of the Judicial Council and its role in our system, and ultimately the pandemic. Throughout the many challenges that arose through the years, Judge Appleby provided calm, focused leadership. There was no one more thoroughly prepared. She listened carefully and thoughtfully, asked difficult questions of anyone and everyone who came before the Council, and ultimately advocated for doing what was best for the public we serve.

I am unsure of the total combined time she served on the Judicial Council and Board of District Court Judges, but it certainly compromises the bulk of her judicial career. There is no compensation and little fanfare for undertaking this kind of work, but it something Judge Appleby has done willingly and enthusiastically for almost as long as she has been a judge. For this, along with a distinguished career, I offer my wholehearted support for the nomination of Judge Appleby for Distinguished Judge of the Year.

The League's volunteer lawyers regularly assist refugees with matters involving asylum hearings and other immigration issues, landlord/tenant issues, law enforcement issues, and defense of refugee rights in school, housing, and employment settings. Notably, the League has provided Utah refugees with "Refugee Rights Cards" that enable them too swiftly request and obtain assistance from the League, it's full-time staff, and its army of volunteer attorneys whenever the need arises.

I serve on the League's board and see first-hand the wonderful impact of the League in our greater Utah community. Every citizen of the State benefits from its service, which makes our communities safer, more vibrant, and prosperous for all of us, not only the refugees it most directly serves. Jim is the prime force behind all of this. It is in significant measure a gift to the community from someone who is motivated and guided by love of humanity and whose excellence has set a higher standard for Utah's legal community and has made our society a better place.

Jim and Brad started the Refugee Justice League of America, a Utah non-profit organization. They both have spent innumerable hours organizing the efforts of the League. The Refugee Justice League of America is a group of attorneys and legal consultants who defend the Constitutional rights of refugees who have been discriminated against on the basis of religion, ethnicity or national origin. The League was founded on the premise that refugees have a right to feel welcome, and to be treated with dignity. League members want refugees to know that they have friends willing to defend their right to live peacefully in their new homeland, maintain their cultural preferences, and practice their religious devotions openly without restrictions or harassment.

Jim and Brad also started Citizens Against Radioactive Waste (CAR) in 1998, a bipartisan group which opposed the storage of radioactive waste and raised public consciousness concerning the storage of radioactive waste on the Goshute Indian Reservation.

Jim received a B.A. in political science and philosophy in 1970 from Brigham Young University where he graduated cum laude. He received a J.D. from the University of Utah in 1973.

From 1977 to 1978, he was an Assistant United States Attorney in Utah where Jim prosecuted crimes involving transportation of stolen property across state lines, mail fraud, wire fraud, embezzlement of funds from FDIC

insured banks, odometer fraud, and racketeering; defended the Department of Health, Education, and Welfare in black-lung matters; was responsible for prosecuting civil rights lawsuits in Utah.

Jim has also taught as adjunct faculty at Westminster College in Utah (where he was a teacher-of-the-year for 1995-1996) and has been involved in numerous other non-profit organizations, including the Children's Aid Society and the Utah Odyssey House.

Brad Parker received a B.A. degree in English with a philosophy minor from Brigham Young University and obtained a J.D. from the University of Utah College of Law.

Rich Mauro is the Executive Director of the Salt Lake Legal Defender Association, which is the organization charged with making certain that indigent criminal defendants receive their 6th Amendment rights in Salt Lake County and other municipalities.

On Friday, March 13, 2020, Governor Herbert announced the closure of schools and other facilities due to the COVID pandemic. Mr. Mauro spent March 14 and 15 putting into motion the systems needed to enable the 165 employees of SLLDA to work remotely, be home with children, continue to represent clients, conduct video conferences for court hearings, and access client information. Laptops were purchased for employees, IT experts enabled employees to access client files, the phone system was reconfigured to enable employees to receive calls remotely, and a video conference program was purchased. SLLDA immediately put in to place safety protocol for employees to make certain that a limited number of people were in the physical building, that they had access to masks and sanitizer, and additional leave was granted to all employees (including part-time employees) to make sure people did not work while they were ill, prior to any government regulations requiring COVID leave

On March 16, the SLLDA office was functioning with most people working remotely, and clients continued to receive excellent care and representation. The 95 lawyers, 35 legal assistants, Social Services, Investigation, and File Processing Teams received continuous communication to enable them to serve clients, be safe, and work remotely.

Mr. Mauro understands that the clients of SLLDA are often at the worst moment in their lives when they come to SLLDA and the employees of SLLDA may be the only people the clients have to listen to them and care for them. Mr. Mauro prioritized making certain the clients continued to be served while protecting the safety of SLLDA employees and clients. Mr. Mauro worked with the court system, jails and prisons to develop protocol to

support these priorities.

Mr. Mauro has practiced law since 1988, representing clients who have been charged with crimes. He began his career at SLLDA and continued his career in private practice. He has been active in the UACDL, national legal defender organizations, CCJJ, IDC, and other Bar related organizations. In 2016, Rich Mauro returned to the SLLDA as its Executive Director.

Mr. Mauro has tried over 60 felony jury trials and 200 misdemeanor jury trials, in both federal and state courts, with some trials lasting several weeks. His experience as a lawyer enables him to mentor the attorneys at SLLDA as they often perform some of the most unpopular but most important work of our society. Mr. Mauro is never too busy to sit down with a new misdemeanor attorney or with a senior attorney in a death penalty case, to listen to them.

In the midst of the COVID pandemic, the national public defender organization planned a day to support racial justice, and, with about 24 hours' notice, Mr. Mauro activated the employees and others in the community to participate in a rally at the City/County Building. (An article is attached)

Also, in the midst of the COVID pandemic, SLLDA was required to movie its offices. Mr. Mauro's leadership enabled the move to occur while keeping employees safe and continuing representation of clients.


Mr. Mauro has worked hard to maintain the morale at SLLDA while the pandemic lasted much longer than expected. The holiday party in December 2020 was on-line and several employees performed skits, musical numbers, and presented artwork. Mr. Mauro identifies SLLDA heroes regularly in his weekly messages to the SLLDA team.

Many people see SLLDA clients only as monsters. Mr. Mauro helps his employees have the training, nurturing, and resources to make sure those clients are seen as people, and receive the rights afforded to them by the Constitution. He has spent his career as a trial lawyer protecting those rights and as a public servant he leads a team that does the same.

# Defense attorneys march in rainy Salt Lake City on day of national demonstrations

SALT LAKE CITY — Dozens of public defenders and their supporters marched in the rain in Utah's capital city Monday, condemning police killings of black people following the death of George Floyd in Minnesota.

Donning masks and huddling under umbrellas, the group of more than 100 joined their counterparts across the country in a somber demonstration, then rallied to seize on public support for broad reforms to the criminal justice system.

Protests nationwide have "raised the debate about issues we bring to the courtroom every day," said Richard Mauro, executive director of the Salt Lake Legal Defender Association. A lawyer of more than 30 years, Mauro said he's watched as lawmakers created mandatory minimum sentences and other policies that gave rise to mass incarceration and harmed generations.

"It's decimated communities of color by robbing people of their dignity, taking away their freedom, and undermining opportunities for education, jobs and hope," Mauro said. "This was true before the pandemic, but frankly it's been exposed much more so as a result of that."

The group trudged about three blocks in a downpour from the legal defender office. As the sky parted, they gathered at the steps of the Salt Lake City-County Building. After chanting "Black Lives Matter," with the Matheson Courthouse as a backdrop, they kneeled in silence for 8 minutes and 46 seconds, the time prosecutors in Minneapolis say police officer Derek Chauvin pressed his knee to Floyd's neck even after Floyd stopped moving and pleading for air.

The attorneys, who provide free legal representation for those who cannot afford to hire a lawyer on their own, answered, "It has to stop now," as Mauro noted defendants who are ethnic and racial minorities tend to be detained more often, serve longer sentences and are more likely to die at the hands of officers. They called for greater anti-bias training for police and bail their clients can afford.

Data from the Utah Department of Corrections confirm elevated rates of minority Utahns behind bars. Hispanic Utahns make up 14% of the state's 3.1 million population, but 19% of its prison population. And although just 1% of state residents are black, they account for 7% of inmates at the prison. Similar trends have taken hold in Utah's juvenile system, despite 2017 state reforms that funnel only youths facing the most serious allegations into courtrooms, said juvenile defender Pamela Vickrey.

"We know a couple years later that while we have had a lot of successes, we have not fixed the overrepresentation of youth of color in our system, and we have to continue to address that," she said.

Attorney Elisabeth Ferguson held a sign that read "still separate and unequal" above a cartoonist's renderings of a white man refusing to wear a face mask and of a black man with an officer's knee on his neck, with both saying, "I can't breathe."

Ferguson has represented black Utahns who were stopped for traffic violations or jaywalking, minor offenses that white travelers rarely face, she said. The initial stops led to further investigation and criminal charges for her black clients.

"Try as I might to represent them the best I can, the system is fraught with systemic racism, and we need to take a stand to show that's not right," she told the Deseret News.

Ferguson took a knee and bowed her head among others carrying signs saying, "Know justice, Know peace," and "Black lives matter to public defenders."

College students Tyrees Sidberry and Deljah Jackson held a bright pink poster that read, "Tired of reading about racism? I'm tired of living it!"

While away at school in Oklahoma, Sidberry said he was driving with a friend who police suspected had shoplifted. After pulling them over, officers emerged from four cars with weapons drawn, Sidberry said, and accused him of selling drugs, although they lacked any evidence.

"Everything that you're reading about, it's worse living through," said Sidberry, who is African American and white.

His mother, Melissa Fulkerson, a defense attorney, said a complete overhaul of the criminal justice system is needed, with a new version that prioritizes mental health and drug treatment.

"It has to change from the ground up, because the system began with racism," she said. "It's based on that premise."

Prosecutors in Utah have voiced similar concerns. Salt Lake County District Attorney Sim Gill joined 40 of his counterparts nationwide last week in urging law enforcers to take immediate steps against racially-biased policing and excessive force.

Public defender Sam Dugan said after the demonstration she is hopeful public scrutiny will foster reform but cautioned new protocols must be followed.

In Salt Lake City, recent policies setting steps for escalation and directing other officers to intervene are not being followed, she said. The force most recently drew criticism in the death of Bernardo Palacios-Carbajal, a 22-year-old armed man shot 20 times.

Alicia Gutierrez, who does administrative work in the federal public defender office in Salt Lake City, said while protests illustrate a tide of support, voters must study up and create change at the ballot box.

"You have to be your own voice," she said.



Dee Benson, the longtime district federal judge who cut a wide swath through the legal world in Utah, died at his home in Sandy Monday. He was diagnosed with Stage 4 brain cancer in April.

Benson, 72, showed up in his office as recently as last Wednesday, driven there by his identical twin brother, Lee, the venerable Deseret News columnist.

By any measure, Benson had a brilliant, far-reaching legal career. He was appointed as a federal judge in 1991 by President George H.W. Bush and served until 2014, when he took senior status. Before that he was the U.S. attorney for Utah, chief of staff for Sen. Orrin Hatch, and associate deputy attorney general in the Attorney General's Office in Washington, D.C., the No. 3 position in main justice.

While serving as a district federal judge, he was appointed by Chief Justice William Rehnquist to the FISA court, and Chief Justice John Roberts appointed him to serve on the Judicial Conference of the United States.

Not bad for a PE major from BYU.

"He had an amazing legal career, just remarkable," says longtime friend Paul Warner, the chief magistrate judge for the U.S. District Court in Utah whose office was next to Benson's.

The hallmark of Benson's judicial career was impartiality, say his peers. There is a public and media perception that judges are influenced by their personal feelings and political leanings; Benson never was that judge.

"These days you hear about so-called Democratic or Republican judges," says Warner. "The media is quick to report a judge was appointed by Obama or Trump, indicating that's what swayed their rulings. Dee loved the law, and he was enormously talented — clearly the quickest legal study I've seen in the 45 years I've been in law. And because he loved the law and knew it, he let the law dictate the outcome.

"He never had an agenda, other than to get it right, and he did his best to get it right — not according to personal beliefs or feelings, but according to the law as he understood it."

Says his brother, "He marveled at people who thought judges were activists or had an agenda."

Besides a keen legal mind, Benson possessed a deep streak of wit, humor and kindness, which engendered friendship and affection everywhere he went. Informed on Friday by phone that Benson's end was near, Sen. Mike Lee, who clerked for Benson, struggled with his emotions and his words.

After talking about Benson for a few minutes, Lee paused and then said, "This is hard for me. He's one of those people you don't expect to be mortal. I'm thrown off by this."

The phone conversation was winding to a close when Lee paused again and said, "I will regret it if I don't say what's in my heart. Do you mind if I take a couple of minutes to do that?"

Continuing, he said, "I don't know if I've ever met a more genuine person. A person without guile in the position of prominence that he had is a true treasure to his fellow beings. All he wanted was to do the right thing. And he was genuinely concerned about the happiness of everyone around him, including those who worked for him.

"He knew everyone in the courthouse. He was sort of like the most popular kid in the school. Everybody's favorite guy. It wasn't just because he was an unusually talented judge. He was just a good person. He made everyone around him happy. I never had a conversation with him when I wasn't happier and more encouraged than I was before. And he was fun. There's not another person like him anywhere."

Benson was the accidental judge in many ways. He never meant to have a legal career.

He grew up on a small farm across the street from the old Jordan High School (now razed and replaced by Jordan Commons). He enrolled at BYU, then took two years off to serve a mission in Sweden for The Church of Jesus Christ of Latter-day Saints. After graduating from BYU in 1973 with a degree in physical education, he was a student teacher and soccer coach at Hillcrest High. He changed his career plans after that experience and applied for law school.

"He only went to law school because he didn't want to be a schoolteacher," says Lee Benson. "His vague plan was to be a soccer coach at a high school. It took one quarter of student teaching to have him fleeing back to school. He said, 'Maybe I'll try law school.' That's how much planning went into that."

He originally applied to the law school at the University of Colorado, but when the paperwork arrived in the mail he realized the school had assigned him to the women's dorm (probably because of the genderneutral name). He called the school and said, "By the way, I'm not a woman." The university rescinded his slot in the school. Benson then turned to BYU, which was just opening the J. Reuben Clark Law School. According to Warner, Rex Lee, the school's founding dean, was determined to hand pick the best and brightest for the charter class and personally recruited many of the students, including some who were headed to prestigious law schools.

"When it got near the end, they tossed in a few oddballs and I was one of them and so was Dee," says Warner. "We weren't recruited. Dee was a PE major and I was an English major — what were we going to do? Dee immediately became a star."

As Warner tells it, Benson worked hard the first semester and "knocked it out of the park." After that, Warner says, Benson took a more relaxed approach to school. His ability to study and grasp legal concepts quickly left him more free time for other activities and sports. During his final year of law school he played for the school's club soccer team. He still finished near the top of his class.

"He wasn't married to the library like other students," says Warner. "He could've finished No. 1 in the class if he had had the inclination. I learned more law from Dee Benson than from any professor. We'd study together and he'd read ahead and then teach me. He was phenomenal. He was a natural-born law student. He stumbled into law, but he was brilliant. He was a star in our class. Equally important, people loved him. There was this affability about him and there always was. He never had the arrogance that so many judges and other brilliant people had."

Warner and Lee both went on at length about Benson's native intelligence. So did his twin brother, who laughed when he said, "Even though we were twins it always bugged me that he was smarter than I was. And that's not false modesty. He was freakin' smarter than I was."

Benson's sharp mind and quick wit were never more on display than during his investiture as a federal judge. The courtroom was packed with politicians, judges and government officials. One by one about a dozen of them roasted Benson. When it came time for Benson to respond, he not only recalled what each of them had said, he calmly answered each of them with repartee, bringing down the house with laughter.

Benson graduated from law school in 1976 and that summer played professional soccer with the Utah Golden Spikers of the American Soccer League. Years later, with typical self-deprecation, he would say that experience made him realize he didn't have a future in professional soccer.

Then he got serious about his law career. He accepted a job with the law firm of Martineau and Mack, which included a car and a nice office. When he realized he had to work six to seven days a week, he returned the car and took a job with Snow, Christensen and Martineau, which proved to be a better fit for him.

Little did Benson know the places his career would take him — that presidents, chief justices and senators would assign him to a wide range of prestigious positions at the highest levels of the legal profession.

"He would fly to Washington and meet with the chief justice and never say anything about it," says Lee Benson. He served as counsel on the Iran-Contra Congressional Investigating Committee. As one of the seven judges on the FISA court for seven years, he flew to Washington frequently to review requests for warrants and wiretaps against people who might be attempting to harm the U.S.

"It was all classified and he couldn't talk about it," says Warner. "It was quite an honor to be asked by the Chief Justice (Rehnquist) to sit on that court. He (Benson) was the gatekeeper."

Later Benson was appointed by Chief Justice Roberts to be one of the senior district judges sitting on the Judicial Conference of the U.S., the governing body of the federal courts.

Even after he was struck with cancer, he embraced his legal work. After a biopsy was performed on May 1 to determine the nature of the growth in Benson's brain, he was bedridden for about a month and was partially paralyzed. By the end of the month, Benson was returning to his office in downtown Salt Lake City.

"It was his life," says Lee Benson. "The court and the law clerks were as much family to him as, well, family."

As he considered the loss of his twin, Lee Benson, who has authored two dozen books in addition to writing an award-winning newspaper column, notes, "He was my best friend and my confidant and my best critic — in the most positive sense of that word — because he would tell me when something I wrote was crap.

"In journalism school they tell you to have one person in mind when you write stories. That person was Dee. I never wrote anything that wasn't to him."

## UTAH STATE BAR Budget and Finance Committee Financial Results as of December 31, 2020 and for the six month period then ended

## FINANCIAL STATEMENT HIGHLIGHTS

### Notable Trends:

- The results of the first half of the fiscal year shows total revenues underreporting compared to the budget, while expenses are also underreporting, thus resulting in a favorable variance of \$214,000 compared to the budget.
  - Interest revenue related investments has been underreporting during the past six months due to the cuts made to the Fed rates since the COVID-19 pandemic began.
  - CLE revenue and facilities revenue are underreporting, both of which was expected but is still difficult to estimate in a budget due to the current restrictions on large gatherings due to COVID.

YTD net income is \$2,306,955 and is \$214,396 over budget.

YTD Net Profit –Cash Basis: Adding back year-to-date depreciation expense of \$82,000 and deducting capital expenditures of \$294,000, the cash basis year-to-date net profit is approximately \$212,000 lower.

# Explanations for Departments with Net Profit Variances \$10k and 5% Over/Under Budget and/or significant activity:

**Admissions:** YTD Admissions revenue is \$144,000, which is \$1,100 (1%) over budget and \$5,000 less than last year's revenue at this time. Admissions expenses are particularly low compared to those budgeted, mostly due to the lower than expected program services expenses; which is due to less examinees at the Fall Bar exam than in prior years. A Bar Exam expense for exam software is also outstanding and a follow up email has been sent to the vendor requesting the invoice. We expect Admissions expenses to even out as the year continues and as a second Bar Exam is administered in February 2021.

**NLTP:** YTD NLTP net spending is approximately \$14,300 more than budgeted and is mostly due to a timing issue related to how salaries and wages expense was spread over the twelve month budget period. We expect this variance to resolve in the remaining six months of the year. All other revenues and expenses are relatively consistent with budgeted amounts.

**CLE:** The CLE department's revenue is currently reporting \$84,000 less than budgeted and expenses are reporting \$117,000 less than budgeted. CLE Registrations is the most significant revenue item for this department, which is underreporting by \$142,000, and is due to the Bar not holding in-person CLE events due to COVID pandemic. Since the CLE department is not holding in-person events, its expenses are also underreporting and significantly less than budgeted.

## UTAH STATE BAR Budget and Finance Committee Financial Results as of December 31, 2020 and for the six month period then ended

**Fall Forum:** The Forum that occurred in October, generated \$55,000 in registration revenue, which is less than budgeted. However, the online format of the Fall Forum resulted in relatively limited expenses. As such, the Fall Forum is currently reporting a \$37,000 net profit, which is \$37,000 over budget.

**Member Services:** Member Services YTD net spending is \$103,000 compared to budgeted net spending of \$138,000. Lower net spending is the result of higher than budgeted advertising revenue for the Bar Journal; and lower than expected expenses related to meeting expenses, salaries and wages and other administrative costs. We note that approximately \$5,000 was budgeted for meetings (meeting rooms, supplies and food) that have not occurred in person and instead have been held virtually due to the pandemic. Additionally, a position in Section Support was vacated in September and has not been filled, therefore reducing total salaries and wages for the past three months. Finally, we note some administrative costs were budgeted related to computer maintenance and copy/printing; although the related expenses have not occurred yet, they may be charged in future months thus increasing net spending and aligning net spending closer to budget.

**Facilities:** As a result of the state-wide ban on large gatherings due to COVID-19, Bar meeting room facilities have been underutilized, which has resulted in lower-than-budgeted revenues and expenses.

**Board Designated Reserves:** In consultation with Bar management and the Budget & Finance Committee, the Commission informally targeted the following reserve amounts:

\*During the June 6, 2020 Commission Meeting, the Board approved building improvements to include interior painting and carpet, and repairs to external concrete areas. During the first six months of the current fiscal year, \$277,070 was spent for concrete, painting and carpet, thus depleting the \$650,000 reserve to \$372,930, shown above.

### UTAH BAR COMMISSION MEETING AGENDA ITEM

Title: Agenda Item #3.2 - Blomquist Hale Request to Increase Fees

Submitted by: John Baldwin

Meeting Date: February 5, 2021

**SUMMARY:** Blomquist Hale Consulting Service has been providing professional counseling to Utah lawyers and their dependents since 2006. In 2009, the Bar renegotiated our monthly fee to them and agreed to a monthly payment of \$6,250.00. There has been no increase in the payment since 2006. The annual payment then has been \$75,000. A copy of the most recent quarterly report is attached.

**ITEM/ISSUE**: Blomquist Hale is now requesting to increase the annual payment for their professional services to \$91,000 per year to cover the increased costs for their services over the past 15 years and for the next several years. Blomquist Hale has agreed to providing services for the Office of Professional Conduct's (OPC) Diversionary Program. An increased emphasis on diversions was an important aspect of the American Bar Association's (ABA) OPC review report. This request would deal with the current needs of Blomquist Hale and would assist the Bar's focus on lawyer well-being and recovery. It is difficult to place an amount on how much of this increase may be attributed to OPC's Diversionary Program but it does constitute some part of the increased amount. The ABA report recommendations were initially implemented by the Utah Supreme Court through an implementation committee and are now being finalized through the OPC Oversight Committee, chaired by Hon. Diana Hagen.





### 1. President's Report: Heather Farnsworth

- **1.1 January Legislative Conference Call Schedule.** Commissioners were reminded of the 2021 legislative conference call schedule.
- **1.2 "Wellness Wednesday" Report.** Heather Farnsworth reported on "Wellness Wednesday" events. There will be an article in the Bar Journal and a January CLE incentivizing law firms to prioritize lawyer wellbeing because data shows that happy lawyers perform better.

### 2. Action Items.

- 2.1 Client Security Fund Report. After reviewing the payment recommendations from the Fund for Client Protection, Andrew Morse moved to approve the recommended payments. Katie Woods seconded the motion which passed unopposed.
- 2.2 Awards Committee Report: Katie Woods reported that awards will still be presented during the pandemic because the Bar should continue to acknowledge professionalism. Ms. Woods reported the Awards Committee was trying to come up with ideas for

presenting the awards remotely. An email was sent to all Bar licensees asking for nominations for Judge of the Year, Lawyer of the Year, Section of the Year, Committee of the Year and Professionalism. Commissioners were asked to nominate and encourage colleagues to nominate. The link to the nomination form was sent in the December ebulletin.

## 3. Discussion Items.

- **3.1 Regulatory Reform Committee Report.** Erik Christiansen reported that on December 10, 2020 the Court halted all bare referral fee arrangements both in and out of the sandbox. Mr. Christiansen also reported that the Court's Innovation Committee released a report on November 20, 2020 describing the sandbox applicants and those that have been approved. After discussion, Mr. Christiansen reported that he will send a letter to the Innovation Committee asking for more details about the legal services being provided by sandbox participants and better explanations of how participants are meeting unmet legal needs.
- **3.2 Excessive Force Committee:** Andrew Morse reported that he and Shawn Newall met with Rod Snow to begin planning a summit on police use of deadly force in Utah. They intend to include all stakeholders and may make a recommendation for changes to Utah's use of deadly force statute.
- **3.3 Discuss Bar Mission, Vision, Short- & Long-Range Goals, Organizational Needs and List Qualifications Desired for the Next Executive Director to Meet those needs.** Commissioners discussed the future of the Bar and qualities they will be looking for in the next Executive Director.
