It is my great pleasure to nominate Jenifer Tomchak for the Dorathy Merrill Brothers Award.

Jen is a truly remarkable individual: a brilliant lawyer, a devoted public servant, and a tireless advocate for the advancement of women and minorities in the profession, with an unparalleled record of service to the bar, the bench and the community.

Having known Jen for 18 years, during which I recruited her to my law firm as a young attorney, worked with her in the practice, served with her on numerous committees, boards and commissions, and enjoyed a close personal relationship with her, I can attest to the fact that she is a tireless worker and creative problem solver, and that she has a strong ethical and moral compass, combined with an easy smile and a great sense of humor, which makes her pleasant, collaborative and easy to work with.

A magna cum laude graduate of Utah State University in 2001, Jen went on to earn joint JD and MBA Degrees from the University of Utah in 2004, graduating Order of the Coif, after a distinguished academic career. She then clerked for Chief Justice Matthew B. Durrant on the Utah Supreme Court, before joining the law firm of Parr Brown Gee & Loveless, where she quickly distinguished herself for her thorough and thoughtful legal work, collegiality, critical and creative thinking skills, impressive work ethic, collaborative approach to problem solving, and remarkable client-relationship skills. She was quickly elevated to shareholder status and hand-picked for some of the most challenging legal teams and important management roles at the firm--always performing at a

consistently high level.

As a result of her exceptional leadership, the Utah Chapter was awarded the 2014 Presidential Excellence Award by the National FBA organization for its statewide programming. Since 2014, Jen has remained active on the FBA-Utah Board, serving as Chair of its CLE and Special Projects Committees, and continuing to provide award-winning leadership to the organization at both the state and national levels.

. Litigation Section – Beginning in 2011, Jen was also asked to join the Executive Committee of the Utah State Bar's Litigation Section, where she continues to provide exceptional leadership. From 2012-2015, she chaired the Young Lawyer and Law Student Division, and was responsible for organizing the Bar's important Modest Means Program, among other initiatives. She also served as Chair of the Aiding the Judiciary Committee from 2012-2015, as Treasurer from 2017-2018, and is the Section's current Chair.

Jen also Co-Chaired the Utah State Bar's 2019 Annual Convention; and is Co-Chair of the Utah State Bar's Leadership Academy.

Books from Barristers – From 2012-2015, Jen served on the Books for Barristers Committee, helping to arrange funding for the purchase of new books to teach the importance of civics to first graders in Title I schools. Ms. Tomchak is a well-recognized leader in the Utah legal community. She has served on and led a number of professional associations. She is a Past President of the Utah Chapter of the Federal Bar Association and Utah Young Lawyer's Division. She continues to serve on both the local and national boards of the Federal Bar Association as a Chair of the Special Projects Committee and an officer of the National FBA's Younger Lawyer's Division. She is the President-Elect of the Litigation Section of the Utah State Bar, the Chair of the Advancement of Women in the Legal Profession Committee, and the co-chair of the Utah State Bar's Leadership Academy. She was the Co-Chair of the 2018 Annual Bar Convention for the Utah State Bar. She was an organizing member of the Books from Barristers Program for the Utah State Bar. She continues to work on diversity issues, having served a Fellowship with the MultiCultural Legal Center and as a current member of the Utah Minority Bar Association and the Advancement Pledge. #### 1. President's Report: Herm Olsen

- **1.1** '20 Legislative Session/Tax Reform. The Bar's lobbyists Frank Pignanelli, Steve Foxley and Doug Foxley were introduced to the Commission. The Commission discussed last year's tax reform effort and resulting legislation and the upcoming 2020 legislative session.
- **1.2 Legislative Conference Call Schedule.** Commissioners were reminded of the legislative session conference call that takes place every Tuesday at 4:00 p.m. during the legislative session.

#### **OUT OF ORDER**

3.2 2020 Leadership Academy Selection Process. Leadership Academy Co-Chairs Jen Tomchak and Cheryl Mori presented the Commission with the proposed 2020 participants. The Leadership Academy was very pleased to present a diverse group that is representative of each of the judicial districts in the state. Jen Tomchak reported on the highlights of last year's academy and outlined the plans for 2020. Katie Woods moved to ratify the Leadership Academy's selection of 2020 participants. Michele Quist seconded the motion which passed unopposed.

#### 2. Information Items.

Regulatory Reform Committee. Chair of the Bar's Regulatory Reform Committee, Judge Tom Willmore, joined the Commission to report on the first meeting of the Committee. Judge Willmore reported that the sense is that the proposed reforms are going ahead without any input from the Bar and that the Committee will therefore focus on keeping lawyers informed about the reforms and any proposed rule changes. The Commission discussed the concern that the reforms are happening so quickly that lawyers have not had time to study the issues. Commissioners expressed concern about ownership and use of client data by tech companies. Some expressed a concern about the lack of transparency about the sandbox and the criteria for participation. Larissa Lee pointed out that the Task Force has a new website, that its meetings are open to the public, and that agendas and materials will be posted on the website. Mark Pugsley moved to ask the Court for an extension of the comment period for any regulatory-reform rule changes from 45 days to 6 months so that lawyers have ample time to study the issues and provide comments. John Bradley seconded the motion which passed unopposed. Herm Olsen will send a letter to the Court asking for an extension of comment period time for regulatory-reform rule changes.

#### OUT OF ORDER

4.2 2020 Approve Fund for Client Protection Recommendations. The Commission reviewed and discussed the Fund for Client Security award recommendations. Herm Olsen pointed out that one claimant was awarded \$250 of a \$500 claim and indicated the Commission should award the entire \$500. Tom Seiler moved to approve the Fund's recommendations with the modification that the claimant discussed be awarded his entire \$500 claim. Chrystal Mancusco-Smith seconded the motion which passed unopposed.

#### 3. Discussion Items.

- 3.1 Proposal to Prohibit "Bullet Voting." The Commission discussed the pros, cons and necessity of prohibiting lawyers from voting for only one of three candidates in Commissioner elections.
- 3.2 2020 Leadership Academy Selection Process. See above.
- 3.3 Position on Resolution to Amend the Constitution. The Commission discussed the permissibility, pros and cons of supporting an amendment to the United States Constitution.

#### 4. Action Items.

4.1 Review Ethics Advisory Opinion 19-03. Billy Walker from OPC and Linda Smith and Kenneth Lougee from the Bar's Ethics Advisory Opinion Committee joined the Commission to discuss whether the Commission should reject Ethics Advisory Opinion 19-03. The Opinion concerns an interpretation of Rule 5.5's prohibition against a nonUtah lawyer having a "continuous and systematic presence" in Utah for the practice of law. OPC believes the Commission should reject the opinion because it is inconsistent with the plain language of Rule 5.5(b) and the Utah Supreme Court's decision in <u>Jardine</u>. After hearing arguments from both sides, **Kati Woods moved to retain the opinion and recommend that the Rules of Professional Conduct Committee make changes to Rule 5.5 to clarify the rule. Michelle Quist seconded the motion which assed unopposed.** 

- 4.2 2020 Approve Fund for Client Protection Recommendations. See above.
- 4.3 Petition to Amend Rule 14-508. Elizabeth Wright asked the Commission to approve a petition to the Supreme Court to clarify language in Rule 14-508. The word "resign" in the current rule is inaccurate and confusing. The Admissions Committee also proposed changes to admissions rules to correspond with the proposed clarification of 14-508 and other "cleanup" changes to 10 admissions rules. Tom Seiler moved to approve petitioning the Court for the proposed rule changes. John Bradley seconded the motion which passed unopposed.
- 4.4 Request to form Cannabis Law Section. Heather Thuet moved to approve the request to create a Cannabis Law Section. Mark Pugsley seconded the motion which passed unopposed.
- **4.5 Approve New YLD Membership Requirements.** Torie Finlinson reported that the YLD Board will vote on expanding YLD membership eligibility from lawyers in their first 6 years of practice to lawyers in their first 10 years of practice. This change will make the Bar's membership requirements consistent with a recent change by the ABA for its YLD membership eligibility.
- 5. Executive Session.

The meeting adjourned for the day at 1:10 p.m.

#### FINANCIAL STATEMENT HIGHLIGHTS

#### **Notable Trends:**

The results of the first half of the fiscal year was, for the most part, as expected. Licensing revenue,
 NLTP and admissions revenue are all reporting under budget. Declining applicants and admittees to the Bar continue to impact these revenue streams.

YTD net profit is \$1.8 million and is \$298,000 under budget, which is the result of the YTD revenue reporting \$200,000 under budget combined with expenses that are running \$98,000 over budget.

YTD Net Profit –Cash Basis: Adding back year-to-date depreciation expense of \$100,000 and adding back in capital expenditures of \$31,000, the cash basis year-to-date net profit is approximately \$69,000 higher.

Explanations for Departments with Net Profit Variances \$10k and 5% Over/Under Budget and/or significant activity:

Admissions: YTD Admissions revenue is \$149,000, which is \$14,000 (9%) below budget and approximately \$11,000 less than last year's revenue at this time. Admissions expenses are \$322,000, or \$40,000 (14%) over budget and \$50,000 over last year's expenses, compared to the same time last year, which is due to the purchase of a new admissions database costing \$60,000.

**NLTP**: YTD NLTP revenue is \$28,200, which is \$8,100 (22%) below budget and last year's revenue at this time. NLTP expenses are \$33,000, or \$4,000 (14%) over budget and \$5,000 over last year's expenses, which is due to the purchase of a new NLTP database during the current year that costs approximately \$1,100 per month.

CLE: The CLE department's revenue is currently reporting \$40,000 less than budgeted, which has resulted in a net spending of \$62,000 compared to budget net spending of \$19,000, a difference of \$44,000. Seminar profit/loss is the most significant revenue item reporting under budget. This is due to some of the prior year CLE events getting closed in the current fiscal year, instead of the prior year, which was due to slow responses from Section leaders approving closure of events. This will likely continue to affect the current year budget-to-actual comparisons. Note that aside from the Seminar Profit/Loss variance, the CLE Registrations and Video Library sales are running close to the budget

amounts. Program expenses are running slightly over budget, but this is largely a timing issue and will likely resolve itself as the year progresses.

Summer Convention: The July 2019 Summer Convention in Park City, is reporting YTD spending of \$31,000. We had budgeted for the Summer Convention to report net income of approximately \$15,000, and therefore, the Summer Convention is \$46,000 under budget. The unfavorable variance is due mostly to lower revenue generate off the event than expected.

Member Services: Member Services YTD net spending is \$162,000 compared to budgeted net spending of \$183,000. Lower net spending is due to lower expenses, which is most likely a timing issue which will align more closely to budget as the year progresses. We also note that currently member Services revenues are \$23,000 less than budgeted, which is mostly the result of lower than budgeted advertising revenue for the Bar Journal. Advertising revenue can be difficult to estimate and fluctuations are not uncommon. Therefore, the variance is not unusual.

Bar Operations: Bar Operations (Management, Finance, General Counsel, IT, and Commission/Special Projects) generated net spending of \$907,000 YTD, compared to YTD budgeted net spending of \$792,000. The higher than projected net spending is mainly due to lower than budgeted interest income and higher than budgeted expenses for Unauthorized Practice of Law (UPL), outside consulting services and staff-related expenses. The UPL expense relates to an ongoing case of an individual who continues to practice law without a license. The expense was not anticipated and was not included in the budget.
